DRAFT EDC Workplan FY1920

Action items to meet EDC objectives

I. <u>Identification of New Businesses That Fill a Neighborhood Market Gap</u>

- a. Develop a toolkit for potential start-up businesses in Pacifica "How to Start a Business in Pacifica" for posting to the City website and distribution to community organizations, residents and potential new business owners;
- b. Conduct community surveys (online, at community meetings, etc.) designed to identify the specific types of goods and services lacking in neighborhoods and business corridors, and identify new businesses to reduce retail leakage

II. Forum for Exchanging Ideas, Education, Information

- a. Conduct community outreach, recruit & encourage residents & businesses to attend and actively participate in upcoming Sharp Park Specific Plan meetings;
- b. Assist in the planning of a 2019 celebration of Palmetto Avenue, involving community organizations, the local business community, and area residents in the process

III. Outreach to the Business Community, Residents, and Visitors

- a. Provide economic development education and information to community residents, businesses and visitors, including information on the benefits of shopping locally, new businesses in Pacifica, and visitor serving information;
- b. Work with the Pacifica Chamber of Commerce through volunteerism and administrative support to promote Pacifica as a visitor-serving destination;
- c. Assist the Economic Development Program with the coordination and implementation of the Shop Pacifica CA Campaign, in conjunction with the Pacifica Chamber of Commerce

WHEREAS, under the direction of the Pacifica City Council, the Economic Development Committee (EDC) exists to support the development of current local businesses and their interface with the City of Pacifica; improve aging business districts, and bring new businesses to Pacifica; and as administered by the Economic Development Program in the City Manager's Office, the Economic Development Committee (EDC) exists to support the City's economic development goals, including the retention of local businesses in Pacifica, the development and expansion of local businesses, and assist in the attraction of new businesses to Pacifica; and

WHEREAS, objectives of the committee are to: (1) Work with the City Manager, to review and develop plans to improve customer service in departments interfacing with current and potential Pacifica businesses; (2) Facilitate owners/operators in existing business districts to organize, develop and implement plans for improvement and business development; and (3) Devise and implement a plan for outreach and marketing of Pacifica to encourage business growth; (1) Work with the Economic Development Program, the community and visitors in the identification of new businesses that fill a neighborhood business market gap; (2) Provide a forum for exchanging ideas, information, and addressing the business and economic needs of the business community and its residents and visitors; (3) Outreach to the business community, residents, and visitors to promote business development and support the implementation of the City's Economic Development Plan; and

WHEREAS, the committee shall have a chair and a vice-chair, elected by the committee with two-year terms; and

WHEREAS, The EDC will be comprised of the City Manager or designee (Ex Officio, non-voting), at least one City Council member as liaison, eight community members appointed by the City Council and one member as designated by the Board of the Pacifica Chamber of Commerce.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the City Council of the City of Pacifica does hereby amend resolutuion no.37-2009 to have be comprised of eight community members and a member as designated by the Board of the Pacifica Chamber of Commerce.
