What makes the fogfest unique?

For the community, run by the community; 900 volunteers put in about 3800 hours.

In 2013, there were 2 boards - \$58000 provided to community.

In 2017, \$116,000 provided back to community

Fogfest facts:

2 meetings with community groups - ~10 days before festival. One after thanksgiving, check distribution meeting.

Festival uses 1 mile of palmetto, all of IBL school and some of Oceana.

No major incidents in the past 5 years.

Sells out booths every year.

Return vendors is above 65%

Serve about 20,000 drinks (non-alcoholic and alcoholic) and 14,000 plates of food.

~100 submissions for bands.

1200 participants in 2018 parade

Fog Jog and Fun Fest coordination with PB&R

Advertised through Tribune, Pacifica Magazine, Bands promote their shows as well, Epoch times, word of mouth, community groups

Analytics, web design, social media is all done outside of the core fogfest board.

All booths go through Jeff who coordinates the layout of the booths.

All palmetto businesses get a free spot.

Are there ways to get more local businesses involved: For less than \$40, you can promote your business in the parade.

There are a total of 56 community groups which benefit from the festival.

Fogfest board is currently looking for new members and letters will be going out in the tribune and shared with city staff.

EDC Workplan FY1920 - Action items to meet EDC objectives

I. Identification of New Businesses That Fill a Neighborhood Market Gap

- Conduct community surveys (online, at community meetings, etc.) designed to identify the specific types of goods and services lacking in neighborhoods and business corridors, and identify new businesses to reduce retail leakage;
- b. Develop and maintain a toolkit for potential start-up businesses in Pacifica "How to Start a Business in Pacifica" - for posting to the City website and distribution to community organizations, residents and potential new business owners.

II. Forum for Exchanging Ideas, Education, Information

- Conduct community outreach, recruit & encourage residents & businesses to attend and actively participate in upcoming Planning Department efforts, including the Local Coastal Plan Update, General Plan Update, and Sharp Park Specific Plan meetings;
- Assist in the planning of a 2019 celebration of Sharp Park Phase I Streetscape Project and support future phases of the Streetscape Project by involving community organizations, the local business community, and area residents in the process;
- Reach out to local businesses and residents to identify opportunities to provide and educate about available City & County Resources.

III. Reach out to the Business Community, Residents, and Visitors

- a. Provide economic development education and information to community residents, businesses and visitors, including coordinating and promoting events and providing information on the benefits of shopping locally, new businesses in Pacifica, and visitor serving information;
- Assist the Economic Development Program with the coordination and implementation of the Shop Pacifica CA Campaign, in conjunction with the Pacifica Chamber of Commerce;
- c. Work with the Pacifica Chamber of Commerce and other Pacifica business supporting organizations through volunteerism and administrative support to centralize fragmented internet resources and promote Pacifica as a visitor-serving destination.
