A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA ACCEPTING THE REPORT OF SEWER SERVICE CHARGES FOR FISCAL YEAR 2021-2022 AND DIRECTING THE FILING OF CHARGES FOR COLLECTION BY THE COUNTY CONTROLLER

WHEREAS, pursuant to Section 6-6.502 of the Pacifica Municipal Code and Section 5473 of the California Health & Safety Code, the City has received a report of sewer charges for Fiscal Year 2021-22, computed in conformity with the City's schedule of sewer charges ("Report") is on file in the Office of the City Clerk and available for public inspection and is incorporated herein by reference; and

WHEREAS, the City Council desires to approve the Report and to submit the charges described therein to the San Mateo County Controller for collection on the 2021-2022 tax roll.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby approves the Report as submitted, and

BE IT FURTHER RESOLVED that the City Clerk hereby adopts the FY2021-2022 sewer service charges in the amount of \$17,514,293 and directs staff to file the necessary documents with the Controller to ensure that the said fees are included on the County of San Mateo Property Tax Roll for Tax Year 2021-2022.

SEWER SERVICE CHARGES FOR FY 2020/21

Adopted FY 2021-22 \$18.81373/100 cubic feet of water consumption (Maximum increase of 7%)

<u>CALCULATION YEAR (March of the previous year thru February of the current year):</u> March 2020 thru February 2021	
<u>MEASUREMENT PERIOD USED FOR RESIDENTIAL CUSTOMERS:</u> Water billings from March 2020 thru February 2021.	
<u>RESIDENTIAL CALCULATION:</u> Actual Annual Water Consump. x 90% x \$18.81373=Sewer Service Charge	
<u>MINIMUM RESIDENTIAL SEWER SERVICE CHARGE:</u>	
48 Annual Units of Water Consumption x \$18.81373	= \$903.06
Prior year minimum charge	= \$843.98

<u>MEASUREMENT PERIOD FOR COMMERCIAL CUSTOMERS:</u> Actual Annual Water Consumption.
