

RESOLUTION NO. 38-2021

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA TO APPROVE AN UPDATED LIST OF PUBLIC STREETS WHERE OVERSIZED VEHICLE PARKING IS PROHIBITED AND DISMISSING ANY CITATION ISSUED UNDER THE OVERSIZED VEHICLE ORDINANCE ON STREETS NOT INCLUDED ON RESOLUTION 10-2020 AND REFUNDING FINES PAID FOR THOSE CITATIONS

WHEREAS, Pacifica Municipal Code Sections 4-7.1204 and 4-7.1205 regulate the parking of oversized vehicles in the City of Pacifica; and

WHEREAS, under Pacifica Municipal Code (“PMC”) Section 4-7.1205(a), the City Council may, by resolution, identify certain streets within the City where it is unlawful to park an oversized vehicle due to safety concerns; and

WHEREAS, the City of Pacifica prohibits the parking of oversized vehicles on: (1) public streets featuring road widths of less than 40 feet, and (2) public streets that have width constraints which cause the street to be unsafe for traffic; and

WHEREAS, on January 27, 2020, the City Council adopted Resolution 10-2020, a Resolution of the City Council of the City of Pacifica Identifying a List of Public Streets Where Parking of Oversized Vehicles is Prohibited (“Resolution 10-2020”), which identified 560 street segments where oversized vehicle parking is prohibited in a list attached thereto marked as Exhibit A; and

WHEREAS, since Resolution 10-2020 was adopted, the City’s Traffic Engineer has further analyzed streets in the City of Pacifica pursuant to PMC Section 4-7.1205, and based upon such further analysis, determined that 14 additional streets should be added to the list of prohibited parking in Resolution 10-2020, while other street segments should be removed; and

WHEREAS, the City has issued 4 citations to individuals who parked in one of those 14 additional streets even though they were not included on the list of prohibited streets in Resolution 10-2020; and

WHEREAS, in order to ensure proper enforcement of the City’s oversized vehicle prohibitions, the City is dismissing any citations that were issued on the list of 14 additional street segments that were not included in Resolution 10-2020 and refunding any fines paid for those citations; and

WHEREAS, the City Council of the City of Pacifica now adopts an updated list of street segments where oversized vehicle parking is prohibited.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PACIFICA that the City Council hereby prohibits parking of oversized vehicles pursuant to PMC Section 4-7.1205 on public streets identified in Exhibit A, attached hereto and incorporated herein, which shall hereafter supersede and replace the list attached as Exhibit A to Resolution 10-2020.

BE IT FURTHER RESOLVED, that the City Council hereby directs the Police Department of the City of Pacifica to dismiss the 4 citations issued on the list of 14 additional street segments that were not included in Resolution 10-2020 and refund any fines paid.
