

RESOLUTION NO. 55-2021

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA APPROVING AND ADOPTING THE 2021 GREENBOOK: STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION AND APPROVING AND ADOPTING THE 2018 EDITION OF THE STANDARD PLANS AND SPECIFICATIONS OF THE STATE OF CALIFORNIA FOR USE IN SPECIFIED PROJECTS, AS THE STANDARD PLANS AND SPECIFICATIONS FOR THE CITY OF PACIFICA

RESOLVED, by the City Council of the City of Pacifica, State of California, that

WHEREAS, the purpose of adoption of standard specifications is to set a level of quality and consistency in construction; and

WHEREAS, the standard specifications can provide language that can be incorporated into public contract documents to guide the behavior and relationship between contractors and the City during construction activities; and

WHEREAS, the standard specifications should be periodically updated to reflect changes in construction practices, materials, and to add clarifications; and

WHEREAS, the 2021 Greenbook: Standard Specifications for Public Works Construction is published by BNi Building News; and

WHEREAS, State of California, Department of Transportation (Caltrans) has prepared the 2018 Standard Plans and Specifications, for use in construction of highways of the State of California; and

WHEREAS, projects within the State Highway System such as Highway 1 or State Route 35 or projects receiving Federal Funds, which are administered by the City, will be required to utilize the 2018 edition of the Standard Plans and Specifications; and

WHEREAS, the City Manager and Director of Public Works recommends approval and adoption of the 2021 Greenbook: Standard Specifications for Public Works Construction and 2018 Edition of the Standard Plans and Specifications of the State of California for Specific Projects of the City of Pacifica for use in the construction of highways by said City, with exceptions as stated herein; and

WHEREAS, this City Council has reviewed and considered the recommendations of the City Manager and Director of Public Works.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pacifica as follows:

1) The City Council hereby finds that the facts set forth in the recitals to this resolution are true and correct and establish the factual basis for the City Council's adoption of this resolution.

2) The City Council hereby finds that the action to adopt this resolution is exempt from the provisions of the California Environmental Quality Act (CEQA), under Section 15061(b)(3) of the CEQA Guidelines (14 Cal. Code Regs. 15000 et seq.) because it can be seen with certainty that there is no possibility that this action will have a significant effect on the environment.

3) The City Council hereby approves and adopts the 2021 Greenbook: Standard Specifications for Public Works Construction, and all subsequently issued editions of the 2021 Greenbook Standard Specifications through January 1, 2031, as the "Standard Specifications" of the City of Pacifica for all public projects, which are not located within the State Highway System and not subject to receiving Federal Funds.

4) The City Council hereby approves and adopts the 2018 Edition of the Standard Plans and Specifications of the State of California, and all subsequently issued editions 2018 Edition of the Standard Plans and Specifications of the State of California through January 1, 2031, as the "Standard Plans and Specifications" of the City of Pacifica for projects within the State Highway System such as Highway 1 and State Route 35 and for public projects receiving Federal Funds that are administered by the City. Wherever the Standard Plans and Specifications refer to authority given to or action be taken by the State of California or any of its agencies or officials, the City of Pacifica or its corresponding agencies or officials shall be substituted therefor. In particular, "Department" is defined as the City of Pacifica Department of Public Works, and "Director" and "Engineer" are defined as the City of Pacifica Director of Public Works and City Engineer respectively.

5) This resolution supersedes any prior adopted resolution adopted Council that may conflict with the subject matter contained herein.

6) This Resolution shall take effect 30 days after its adoption.




