CITY OF PACIFICA ECONOMIC DEVELOPMENT COMMITTEE

Minutes of December 11, 2012 Approved on January 8, 2013

1. Call to Order

Vice Chair Sam Casillas called the meeting to order at 6:02 pm.

2. Approval of November 7, 2012 Minutes

The November 7, 2012 minutes were approved on a motion made by Sue Vaterlaus and seconded by Mike Ervin. The motion passed.

3. Sub-Committee Reports/Discussion

The committee agreed to move Objective #3 to the beginning of the meeting as there was a guest speaker on that item.

Subcommittee for Objective #3 Report

City Map Update

Sam mentioned that everything set forth in the objectives now appears in the Map, including trails, blowouts of different areas, events, activities, Open Space, Businesses and Services, plus legends.

Steve Patterson, publisher of Bay Area News Groups (BANG) was in attendance. He was planning on re-doing the Tribune's map and, after recently meeting with Sam and Courtney, has decided to join forces and keep ONE map. He carried large scale samples of the map for the committee to view. His department can edit the copy down to half the present size by removing some of the wordiness, and, by using different fonts and italics, they can make the appearance more interesting.

Mary Ann was curious if there was heavier paper that would make the map more durable. Mr. Patterson would look into it. He also suggested finding additional advertisers such as Sports Authority and Hertz, to name a few. Additional items to put on the map would include fishing and surfing spots, kayaking launch points, and difficulty levels for our trails.

The next step would be to develop a spec, but first files will need to be gathered from Stephen Johnson, the previous photographer. Mr. Patterson will bring a spec hopefully to the next meeting, and the goal will be to eventually digitize it.

♦ Encouraging Sporting Events in Pacifica

Javier mentioned that bringing a tournament to town is on hold due to winter and drainage issues at Fairway Park. He is hoping to revisit this before tournament season starts in June.

Mike discussed the cross country event from the previous EDC meeting. The main issue is the date, with August and September typically being the pre-season warmup. The Committee would like to have the Terra Nova coaches return to the next meeting, and Courtney will bring an update from the hotels as to occupancy rates for those months.

Javier inquired about the Oddstad site which is up for sale by the school district. It would be a great venue to hold a sporting event. Sam said he would look for available grants for non-profit youth sports.

Small Business Incubator

Volunteers were sought for a tour to a Sunnyvale incubator site on December 19th. Due to conflicts with the proposed time, tentative attendees are Victor, Mary, Jim and the City Manager.

Victor spoke to Nicole at Kimco who told him that Kimco has possible leases for all the empty spaces in Linda Mar. She can't commit to anything until January, which is when Victor will follow up with her.

Mary brought up starting the economic development non-profit which appears to be possible with minimal effort. She inquired if the City Attorney can assist with the process, and the City Manager will check and provide a response at the next meeting.

Mentoring Program

The Chamber will put an ad in their newsletter to start generating a list of mentors. Victor will draft the verbiage with Mary and Courtney.

Art Space Use

Vasu continues to communicate with the Art Guild and their Board. The landlord would like to see it be a little more active. The holidays would have been a perfect time to do something special, but they have chosen to put the exhibits on hold until February 1. Vasu will continue to talk to both.

Movie Night

Victor Spano stated that since it is now winter, we will revisit this in the Spring. He will look for a buy-in from the Centers hosting the movie to cover the costs.

4. <u>Participation in selection of consultant for development of the Economic Development Plan</u>

Mary announced that after a lengthy selection process, Wahlstrom & Associates/Susan Barnes were chosen as the consultant to develop the City's Economic Development Plan. Wahlstrom and Barnes paralleled Pacifica to Malibu in a very organized, convincing and knowledgeable manner. They demonstrated great flexibility in working with the City.

The City Manager announced that City Council approved the contract with Wahlstrom and Barnes at their December 10th City Council meeting. The City Manager will invite the consultants to attend our next meeting in January.

Sue Vaterlaus noted that the Rockaway Beach Tree Lighting event was very successful, and most stores reported doing very well.

Mary Ann thanked everyone on the committee. She has been quite pleased with how the EDC has taken shape and is proud and impressed to have been a part of it.
