# Minutes of September 8, 2010 Approved 10/12/10

#### 1. Call to Order

Chair Murphy called the meeting to order at 6:09 pm.

# 2. Approval of August 10, 2010 Minutes

The August 10, 2010 minutes were approved on a motion made by Sue Vaterlaus and seconded by Jim Heldberg.

#### 3. Subcommittee Reports/Discussion

**SC #1** –Mike Ervin reported that they are getting completed surveys. Courtney Conlon told about Sunnyvale and how it was known for having a good permit process.

**SC#2** – Courtney Conlon reported that Florey's got the Wells Fargo Business Improvement grant.

**SC #3** – Jim Heldberg reported that work on the map continues but it is not yet complete. He told about the Convention Bureau's visit with travel writers who took a tour of Pacifica on Segways. Courtney Conlon talked about the upcoming changes to the marine display at the Chamber and the potential for a diorama of the City to be developed at the Visitor's Center.

# 4. Highway 1 Business Route Designation

Chair Murphy explained his concept of having a Highway 1 Business Route designation from Caltrans in Pacifica. The proposal would be to designate Palmetto for southbound traffic and Oceana for northbound traffic. This should increase the visibility of those streets and perhaps help with the development of restaurants and other commercial uses. The process would be for the Committee to make a recommendation to the City Council and then if accepted by the Council, staff would contact Caltrans to initiate discussions on the idea.

Members of the Committee felt this was a good idea that should be pursued. A motion was made by Courtney Conlon to recommend to the City Council that Pacifica pursue the Business Route Designation for Highway 1 through the

Manor and Sharp Park areas. The motion was seconded by Sue Vaterlaus and passed by the Committee.

#### 5. Pacifica Democrats Meeting Report

Discussion followed on the value of the meeting and the ability to share with the community what is being done for economic development in the City.

## 6. Palmetto Streetscape Presentation

The goal is to begin implementation as a part of the utility undergrounding project that is planned for 2012. An association of property and business owners has been started to make sure they are closely involved in the process. Discussion followed on how the Committee can help promote the district and make contact with the owners.
