Commissioner Blackburn inquired about any timeline to return to in person commission meetings. Captain Clements reported that the City Clerk's Office was anticipating further updates on a return to in-person public meetings in the coming weeks.

Commission Vice Chair Hladky recognized Chair Salisbury and the fine job she did presenting the commission's annual report to City Council. He also restated the City Council's response to the commission's report; he shared council members spoke about the City looking further into ordinances regarding brush removal and other fire mitigation measures, and exploration of grant funding for future fire mitigation efforts.

COUNCIL LIASION COMMENTS: Council member Bigstyck reported City Council passed the annual budget. He also shared from the Open Space and Parkland Advisory Committee, the City would be drafting a letter to the GGNRA (Golden Gate National Recreation Area) regarding the impacts visitors to the Mori Point Recreation Area have had on the surrounding neighborhood.

Guest Presentation: Director Nicholas Calderon of the San Mateo County Parks Department. Director Calderon presented the county parks department's comprehensive 5 year plan for wildfire fuels management. This plan included 32 distinct projects. Of local interest he spoke about the two projects in San Pedro Valley Park. One project included the creation and maintenance of a fuel break along the park boundary and private Pacifica residences. This project is already underway. The other project is the creation and maintenance of a fuel break along the Hazelnut Trail. A funding source for this project is being sought, and the project is anticipated to be completed in the coming years.
