Commissioner Johnson said the topic was regarding the heritage tree ordinance in the City of Pacifica and how these trees pose a threat to the community in the event of a wild fire.

STAFF COMMENTS:

Deputy Chief Kavanagh and Safety Inspector Adams from the North County Fire Authority (NCFA) conducted a presentation on Wildfire Preparedness Grant Programs for the City of Pacifica. NCFA had recently applied for more than \$1,000,000 in grants through CalFire, the Coastal Conservancy and the California Fire Foundation to support a local vegetation reduction community chipping program, roadside vegetation management, public education on fire prevention, fuel reduction projects, and emergency 'go bags' for use in evacuations. The Coastal Conservancy grant had been awarded for \$130,000 and the vegetation reduction program was already planned to begin in August. The other grant awards were expected to be announced in November.
