RESOLUTION NO. 66-2021

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA AMENDING ADMINISTRATIVE POLICY NO. 1 "CITY COUNCIL AGENDA AND FORMAT PROCESS" TO INCLUDE THE READING OF A RAMAYTUSH OHLONE LAND ACKNOWLEDGEMENT

WHEREAS, the Ramaytush Ohlone people are the original people of San Francisco Peninsula and Pacifica, and that their ancestral village of origin is located along Calera Creek; and

WHEREAS, the City of Pacifica acknowledges that we occupy the unceded ancestral homeland of the Ramaytush Ohlone people who were the original inhabitants and stewards of this land; and

WHEREAS, the City of Pacifica acknowledges that the Association of Ramaytush Ohlone has actively worked to research, expand public awareness of, and preserve Ohlone history and culture; and

WHEREAS, the City of Pacifica acknowledges that the Ramaytush Ohlone peoples have survived the brutalities of colonialism, enslavement, genocide, discrimination, racism, gender-based violence, theft, forced assimilation, and other atrocities driven by local, federal, and state government; and

WHEREAS, the City of Pacifica acknowledges that Ramaytush Ohlone peoples are not a mythical population of the past, but an integral and active community in the present San Francisco Bay Area region, and beyond, whose ongoing exclusion and invisibility denied the greater Native American community's inclusion and respect in San Francisco; and

WHEREAS, the City of Pacifica affirms their sovereign rights as First Peoples and wish to pay respects to the ancestors, elders, and relatives of the Ramaytush Ohlone; and

WHEREAS, a formal land acknowledgement is intended to share an expression of respect for indigenous peoples, recognize their enduring relationships to the land, and raise awareness about marginalized aspects of histories; and

WHEREAS, the City of Pacifica land acknowledgment process does not have any legal force or effect and is solely designed to pay respect to the indigenous people that occupied land in Pacifica before settlement.

NOW, THEREFORE BE IT RESOLVED, that the City Council of the City of Pacifica hereby amends Administrative Policy No. 1, to include the reading of a land acknowledgement at the beginning of each City Council meeting, in Attachment 1, which is attached hereto and incorporated herein by this reference.
