COMMISSION COMMENTS:

Commissioner Shaw spoke about the North County Fire Authority sponsored Wildfire Preparedness Event at fire station 72 on June 30, 2018. She commented on the valuable information that was available, but acknowledged the attendance was very low at only 13 community members. She suggested promoting similar events in the future with more signage visible from the roadway.

Commissioner Carroll spoke about a recent emergency preparedness exercise she attended for the San Francisco Public Utilities Commission. She mentioned staff from

North Coast County Water District were in attendance and participated. She also spoke with the NCCWD representative about a presentation to the EP&SC in the future. Commissioner Carroll spoke about the importance of the City supporting NCCWD emergency planning and preparation.

Commissioner Carroll spoke on behalf of the sub-committee. The sub-committee proposed coordination of presentations from a variety of groups such as the water district or other City departments about emergency preparation.

Commissioners discussed the final preparations and staffing of the commission's booth at Fog Fest on September 29 & 30. This is the commission's largest community outreach event of the year.

Council Member Martin also attended the Wildfire Preparedness Event. She spoke about the valuable information available and thought it was unfortunate it had not been better publicized and attended. She suggested perhaps a different location could be considered for similar future events to raise visibility and it could be promoted differently.
