In attendance were Chair Patton, Vice Chair Arnos, Natesan, Shoemaker, Read, Johnson, Sullivan, and Lancelle. Durkee was absent. Mayor Bier and Staff Liaison O'Connor were also present.

CALL TO ORDER: Chair Patton called the meeting to order at 6:00pm.

ADMINISTRATIVE BUSINESS:

Approval of Order of Agenda Chair Patton recommended to continue Item 6 to a future meeting. Unanimously approved as amended.

Approval of Minutes of December 15, 2021. Approved unanimously.

PUBLIC COMMUNICATIONS:

Oral Communications: *Erin Macias* made comments regarding fragmentation of high value habitat and would like OSPAC to expand their advisory scope to protect habitat fragmentation.

INFORMATIONAL ITEMS:

- 1. Update by GGNRA/GGNPC. Darren Brown, GGNRA, the Park Superintendent has name David Schifsky as Deputy Park Superintendent. Sue Gardner, GGNPC, Mori Point restroom is currently out of service; programs with Oceana H.S. have restarted; Links summer high school program will be commencing this year and will be in-person. Gardner will distribute an application; Natural Resource team will do mission blue butterfly translocation work near Sweeney Ridge.
- 2. Update by City Council Liaison. *Mayor Bier* reported new staff in the Planning Department, City was granted money to fix the municipal pier, Omnicom surge continues, thankful no notable damage from the recent tsunami advisory, recognized the release of General Plan, and goal setting at the end of February.

STAFF COMMUNICATIONS:

3. Development project and General Plan updates. *O'Connor* provided updates on the GGNRA meeting to discuss Mori Point, development application statuses of 10 Gypsy Hill (Parcel 7), 4000 Palmetto Ave (Parcel 2), and the Quarry Reclamation (Parcel 11), and a description of the General Plan and EIR, information about the public release, and how to comment on the documents.

DISCUSSION ITEMS:

- 4. Provide feedback on the development application for TBD Amapola Ave. (APN 018-160-090) (Planning Department File No. 2020-021) related to Open Space Task Force Report (Parcel 15) Project Applicant *Len Stone* and Deputy Director of Planning, *Christian Murdock* were present to respond and accept feedback. *Christine Boles* asked questions regarding HPD, distance to creek, and fire access.
- 5. Discuss the creation of a new subcommittee to research funding options to preserve and maintain open space in Pacifica, approve subcommittee members. *Shoemaker, Read, Johnson*, and *Patton* were unanimously approved to be the subcommittee members of this new subcommittee. *Arnos* notes that a subcommittee, such as this, is supported by the existing General Plan. *Erin Macias* noted her support.

- 6. Update on Pedro Point Headland Coastal Trail. Item continued to a future meeting.
- 7. Update on the 2022 Preservation Award nominations and progress. *Arnos* noted that she received a verbal nomination for Hal Bohner.

COMMITTEE COMMUNICATIONS: *Patton* encouraged the OSPAC members and the public to contact other City Council members regarding the resolution update. *Arnos* noted that OSPAC used to have liaisons to other committees and wants to consider reestablishing them and would like this item agendize in the future. *Shoemaker* supports Arnos' idea. *Sullivan* provided gratitude to GGNRA trail crews for their field maintenance. *Lancelle* provided her general appreciation. *Natesan* provided notice of the state level for the 30 by 30 Initiative.

ADJOURNMENT Chair Patton adjourned the meeting at 7:30pm.

Dear Bonnie and Arlene,

I am nominating Peter Loeb for the Open Space Preservation Award. He has spent decades working tirelessly to preserve open space in Pacifica.

Peter was a founding member and co-chair of Friends of Pacifica, which was formed in part in response to a proposal for hundreds of condos on Mori Point. Under Peter's leadership, this group began the long process of working to preserve Mori Point as open space. Friends of Pacifica also took a new zoning ordinance to referendum and the zoning ordinance was defeated. This led to the creation of the Zoning Ordinance Review Committee (ZORC). Peter was appointed by the City Council to serve on this committee.

Peter was elected to City Council on an environmental platform. During his time on the council, the Growth Control Ordinance was adopted as well as the ordinance to require a public vote to develop housing in the quarry. Peter co-chaired the Open Space Task Force which resulted in the 2-volume Open Space Task Force Report.

As Mayor, Peter was the host of the federal ceremony dedicating Sweeney Ridge into the GGNRA. While he was on City Council, Cattle Hill was acquired for later inclusion in the GGNRA.

Peter was one of many people who contributed funds to allow the Trust for Public Land to buy Mori Point at auction. Later, Mori Point became part of the GGNRA.

Also while on City Council, Peter was an early supporter of the Devil's Slide tunnel and opposed to the bypass. After his service on the Council, Peter was a founding member of Pacificans for Sustainable Development.

Peter's leadership, together with a City Council that understood the importance of the environment, and his continued advocacy following his two terms on the City Council, has allowed for the permanent preservation of open space that makes Pacifica what it is today.

Nomination Process and Selection Criteria

- 1. Awardees will be individuals or groups who have contributed to preserving or maintaining Pacifica's open spaces, parklands or other areas adjacent to Pacifica.
- 2. Awardee will not be a member of OSPAC.
- 3. Awardees will be nominated by members of the public as well as OSPAC committee members
- 4. Awardees will be voted on by OSPAC members by secret ballot.
- 5. OSPAC will award one Preservation award per year.
- 6. Awardees will not be eligible for future Preservation awards.
- 7. Nominations should be received in writing by OSPAC by the date set forth by the committee.
- 8. Nominees may be nominated for the award again if they didn't previously win but names will not carry over the subsequent year. Nominees must be re-nominated by either committee members or members of the public.
- 9. OSPAC will sent a thank you letter to the person who submitted the nomination, thanking them for their time and nomination.
