## **DISCUSSION ITEMS:**

- **4. Review Final Draft Proclamation for 2019 Preservation Awardee, Pacific Beach Coalition.** The committee unanimously voted to approve the language with the addition of adding the word "creek" to the last recital.
- **5.** Coastal Trail Signage Update: Patton provided an update of the signage, 11 locations were posted, 5 locations remained. She anticipated the work would be finished next week.
- **6. Discuss and Develop General Process for Trail Naming Effort:** A subcommittee was unanimously approved and includes Natesan, Daniel, and Sullivan. Ron Maykel provided some information about Ohlone history and terms. The committee discussed the need for public input, reaching out to schools, reviewing suggestion by a representative of the Ohlone tribe as well as a linguist. Item was continued to next meeting.
