A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA
REQUESTING FY21-22 GRANT FUNDING IN THE AMOUNT OF \$4,085,052 FROM THE
STATE OF CALIFORNIA DEPARTMENT OF PARKS, DIVISION OF BOATS AND
WATERWAYS (DBW) SHORELINE EROSION CONTROL GRANT PROGRAM FOR THE
310-330 ESPLANADE INFRASTRUCTURE PRESERVATION PROJECT

WHEREAS, the Shoreline Erosion Control Grant Program is administered by the DBW and can assist in the planning and construction of all types of beach erosion control and shoreline stabilization measures, including hard structures like seawalls; and

WHEREAS, the 310-330 Esplanade Infrastructure Preservation Project consists of armoring the toe of a 70-80 foot bluff adjacent to Esplanade Avenue, a city road; and

WHEREAS, the City would like to construct a seawall that will visually mimic the surrounding area with a sheet pile below sand level to protect from scouring and a shot-crete, tie-back seawall above sand level and remove a rock revetment that is scattered at the project site; and

WHEREAS, the project will create an engineered solution to protect public and infrastructure, private property, public health and safety, recreational use and beach access, and anticipate changes in sea level rise; and

WHEREAS, the City of Pacifica is requesting a Shoreline Erosion Control Program grant of \$4,085,052 from the California State Parks Division of Boating and Waterways to help fund the 310-33- Esplanade Infrastructure Preservation Project; and

WHEREAS, should the City of Pacifica receive the Shoreline Erosion Control Program grant of \$4,085,052, a City match in the same amount would be provided; and

BE IT RESOLVED by the City of Pacifica that, pursuant and subject to all terms and provisions of the Shoreline Erosion Control Program application be made to the State of California, Department of Parks and Recreation, Division of Boating and Waterways for funding; and

BE IT FURTHER RESOLVED that the City Manager of the City of Pacifica or his/her designee is hereby authorized to cause a copy of this signed Resolution to be filed with the City's Shoreline Erosion Control Grant application at the Division of Boating and Waterways.
