Subject: Administrative Update

On the following pages you will find our December/end-of-year quarterly reports, representing the final three months of programs and activities of 2020. I want to express my appreciation to the hard working Parks, Beaches and Recreation (PB&R) staff for all their efforts this past quarter as well as the entirety of 2020. As we have now passed the 10-month mark since closing down most of our programs and facilities on March 16, 2020 due to COVID-19, it is important to note the commitment and perseverance of our employees who are working hard to be of service to our community.

Budget

Due to the impact of COVID-19 on our programs, we are experiencing a decrease in revenue. However, we are also experiencing decreases in expenditures. At the end of December, staff began analyzing our year-to-date financials as part of an earlier mid-year budget process. At the time of the writing of this report, City staff are hard at work preparing this information. It is anticipated that the City Manager and Assistant City Manager will deliver the mid-year budget report to City Council on February 8. Soon after, the annual budget "season" process will start with work on the 21/22 fiscal year budget.

Staffing Update

Amy Andonian was hired as our new Recreation Manager for the Parks, Beaches and Recreation Department, filling the spot of Jim Lange who recently retired. Amy spent the past six years serving as the President and CEO of Avenidas, a well-known nonprofit organization based in Palo Alto that delivers a wide variety of innovative programs and services for older adults living in Northern Santa Clara County and Southern San Mateo County.

She has a rich background in nonprofit administration, program management, fund development, and social work, specifically working with older adults and their families. She earned a BA in Human Biology from Stanford University (concentrations: Gerontology and Public Health) and completed anthropological research at the University of Queensland in Australia.

Prior to joining Avenidas in 2014, Amy was Vice President of the Home Care & Support Services Division at the Institute on Aging and a Program Director of Adult Day Care and

Caregiver Support Services at Catholic Charities of Santa Clara County. Amy's first day is January 19, 2021. Her office is in the Community Center and she can be reached at 650-738-7352 or aandonian@ci.pacifica.ca.us

2021 Commission Work Plan Items

At last month's regular meeting, Commissioners discussed 2021 work plan items, reaffirmed staff recommendations and added a few items to the list. Those items include:

- **Surf Camp/School Policy** this item has been on several regular meeting and study session agendas since the summer and was a standalone item for consideration at the December 16, 2020 meeting. Commission approved staff recommendations which included:
 - Suggested minor edits/changes to the existing policy for 2021.
 - Extension of current CAPP program for 2021.
 - Creation of a working group committee that will make recommended changes to the policy in order to create a Community Access Partner Permit (CAPP) program as well as address overall policy considerations. This included a suggested timeline – to begin in February and to report back in June.
 - Appointed Commissioner Kellogg and Chair Abbott to the working group subcommittee.
- Tree Appeals Commission was looking for help, information, clarification and background to assist in decisions they can make on mitigation as well as assessment on items relating to tree appeal decisions to aid in preparation and an increase in knowledge. Although there is an RFP moving forward for work through the Department of Public Works (DPW), there is a strong possibility that appeals will come up prior to the completion of that work. They had requested something like an educational session. Staff has been in contact with City admin, DPW and Planning and will work on such a meeting where existing codes and procedures can be clarified and other potential concerns/questions can be addressed as appropriate.
- Poet Laureate In 2013, the selection of the City's Poet Laureate became the responsibility
 of the PB&R Commission. The Poet Laureate's serve three-year terms. Our current Poet
 Laureate, agreed to continue past her term as we were coming to grips with COVID-19.
 Choosing the next Poet Laureate can be part of the 2021 work plan should Commission wish.
 Commissioner Benton Shoemaker and Chair Abbott volunteered to be on the ad hoc
 committee.
- **Bike Park** In November there was a PB&R Commission/City Council joint study session on the Bike Park topic, which included a presentation from the Bike Park Committee. Based on discussion and input from this meeting, the Bike Park Committee will begin working on items relating to next steps including looking closely at their survey info, using Flash Vote as another surveying method and more evaluation on site selection. Recreation Coordinator Anthony Schriver is the PB&R staff liaison to the group, and Commissioners Kellogg and Lusson have volunteered as liaisons. Commissioner Marchetti volunteered to be an alternate.
- **Bike and Pedestrian Master Plan** Commissioners asked about next steps and updates on the plan and any projects. Deputy Director of Public Works, Sam Bautista, reported that as

grants are available staff will apply. Information and/or the need for Commission/B/BAC input will be made available as appropriate.

- Parks Master Plan Currently there is no master plan for the parks; however, there is a
 Capital Improvement Program (CIP) to address upgrades to City playground structures. The
 department did go through a master plan process, which was not completed, over 15 years
 ago. Staff will discuss the idea with DPW staff and bring this item back to the Commission
 later in the year.
- **Liaison Assignments** At the December meeting Commissioners volunteered for various liaison assignments, which are attached to this report.

SUBJECT: Aquatics Division Update October – December, 2020

Adult Lap Swim and Water Aerobics

During the months of October through December we were able to operate Adult Lap Swim and Water Aerobics at the Terra Nova Outdoor Pool with restrictions set in place by San Mateo County and State of California. Restrictions include:

- 45 minute lap swims with a reservation only.
- All persons in the facility are required to wear face masks except when they are in the water.
- Participants are able to reserve a lap lane through sign up genius and pay the \$10.00 fee. Water aerobics operates the same but with 10 participants spread out in one lap lane with a one lane buffer Tuesday through Thursday at 10am and 11am.
- Participants are physically distanced six feet apart at all times.
- Participants entering the facility must have their temperature checked with a touchless thermometer and do a self-health screening to ensure they are not showing symptoms of the COVID-19 virus.
- Participation is limited to one person per lap lane,
- Swimmers must come to the pool prepared to swim in their swim suites.

Unfortunately, due to State regulations the locker rooms, showers, and water fountains are closed to help minimize any potential spread of the COVID-19 virus. Only the bathrooms are open for use when needed.

The attendance for both Lap Swim and Water Aerobics was as follows: October - 1,793, November - 1,382, and December - 1,059 for a total of 4,234 participants safely using the pool. At \$10 per swim this generated a revenue total of \$42,340.

Participants have been thrilled to get back in the pool since most gyms, fitness centers, yoga studios and other indoor pools have been closed during this COVID-19 Pandemic. Swimmers have been very complementary of our safe operation.

Back in August of 2020, all indoor pool operations were shut down due to State of California regulations. This effected indoor businesses such as gyms, fitness centers and indoor pools. We were able to reopen at Brink pool November 7th – November 16th only to be shut down again on November 17th. This was once again very unfortunate for our swimmers and water aerobics participants. We moved quickly on the 16th of November and were able to shift our pool operation safely back to the Terra Nova High School Outdoor Pool the following day on the 17th.

Swimmers have been very grateful and thankful for our services as swimming is very therapeutic, great exercise and indoor pools are not an option for swimming right now. All safety regulations and protocols which were used at Jean E. Brink pool have been carried over to Terra Nova. A couple of changes had to be instituted because of some restrictions in using Terra Nova. There is one less lane which limits the water aerobics to 10 instead of 20 and the inability to collect fees (due to Wi-Fi and security issues) forced us to look at other ways to collect the fees. Fortunately sign-up genius has the ability to collect the fees for us and send us a check. We are so thankful and grateful to the Jefferson Union High School District for allowing us to utilize the recently renovated TNHS Pool at no additional cost.

One drawback to using an outdoor pool is the weather. During the fall and winter months swimmers face the possibility of inclement weather from both cold and rain. Our dedicated swimmers and staff have been braving the elements and powering through. Thankfully we have still been experiencing some very nice weather.





On July 20, 2020 Pacifica Senior Services introduced a new aquatics program—"Sirkka Niukkanen Senior Swim Program". This program is designed to subsidize the difference between the current COVID-19 fee and the pre-COVID-19 senior fee.

I.e. Current COVID-19 Senior Drop in fee: \$10.00
Pre-COVID-19 Senior Drop in Discount fee \$5.00
Sirkka Niukkanen Senior Program subsidy \$5.00

This program is for residents of Pacifica who are seniors 60+ years of age. Senior participants will continue to pay \$5.00 per swim and must reserve a lane Monday-Saturday 8am -2pm through the online reservation system, signupgenius.com. Swim slots are one hour (45 min. swim) and COVID-19 aquatics restrictions must be followed. In order to qualify for this program you will need to provide a photo ID showing both your birthdate and address the first time you swim. Due to the generosity of Ms. Niukkanen 1,311 swims were provided to the seniors in our community during the months of October-December. Many of these seniors are on fixed incomes and they are so grateful and appreciative of this swim program during these unprecedented times. A huge thank you to the Senior Services Division and the Sirkka Niukkanen Swim Program and Sirkka Niukkanen Trust Fund.





Pacifica Sea Lions workouts (PSL)

PSL Swim Team Members 12 and up have been conducting workouts similar to our adult lap swim program. Parents of PSL athletes are able to make a reservation for 45 minute coached workouts. Cost for these workouts are \$10 per PSL member. Parents are delighted and thankful for our PSL workout programs M-F 3:00-6:00pm. In October we had 396 swimmers workout bringing in \$3,960. In November we had 414 swimmers workout bringing in \$5,600 and in December we had 340 swimmers bringing in \$3,400 totaling \$12,960. Participation number may have dropped due to smoke, cold weather and holidays. We will continue to hold PSL workouts at the TNHS Pool until we are allowed to go back to the Jean E. Brink Pool.

I would like to commend all of our dedicated staff for their service as they are our frontline workers serving our community for a sport and workout loved by many participants. Participants have, and continue to commend our staff! They are constantly thanking us and commenting on how awesome and amazing a job we are doing and how safe they feel while in our pools. We are happy and it's our pleasure to be of service.

QIRS GRANT

The Child Care program received Quality Improvement Rating System (QIRS) grants again this year totaling over \$17,000 from the County. The Child Care staff used a portion of this money to purchase:

- Five iPads for the preschool classrooms,
- Complete Ages & Stages Questionnaires (ASQ) Program that provides reliable, accurate developmental and social-emotional screenings for children
- Numerous other classroom purchases to support social-emotional learning.

PART-TIME STAFF RECRUITMENT UPDATE

The Child Care division is in the process of hiring three part-time staff to satisfy the continued need for additional classroom support. As the pandemic continues, the maximum number of children per classroom remains at 14. Although the classroom numbers are small, Child Care employees must continue to provide support for distance learning as well as practice continued disinfecting and sanitizing procedures in addition to regular day to day classroom management tasks. The hiring of these additional part-time staff will allow for full-time staff to be able to take some much needed time off.

CHILD CARE RELIEF FUND

The Child Care division received a San Mateo County CARES Act grant in the amount of \$55,000. These funds were distributed after submitting an application to support Child Care programs adversely impacted by COVID-19 that provide Child Care services to the most vulnerable children.


Good elves sanitize their hands, Before and after playing at the park, They love to sing and dance to bands, Especially on Christmas Eve after it gets dark.




Letters to Santa

Due to the cancelation of the Annual Holiday Extravaganza, PB&R joined forces with North County Fire, Pacifica PD, and Pacifica Public Works to bring Santa to Pacifica. Community members were encouraged to wave to Santa while following Covid precautions. Santa was on the vintage Pacifica fire engine and we had Mrs. Clause on the Pacifica Police Department's open air vehicle. There were two routes taken; one route focused on the south end of Pacifica and one focused on the north end of Pacifica. The event was posted on Facebook and Nextdoor to drum up participation and the City

encouraged social distancing. Our goal was to bring joy to the community while living in a time of social distancing and sheltering in place. A link to a live tracking app was provided so that community members could follow where Santa was located. With this new app we were able to see that 320 people were following Santa's route. There was great participation from the community and the event was well received.







Pacifica Community Center

Between the months of July and September, the Community Center was unoccupied to community renters. The building was used for Seniors Meals on Wheels and Seniors Grab and Go lunch. Ongoing Rentals and Special Event Rentals stopped March 13th due to COVID19.

Manager's Report

Funding update:

Pacifica Senior Services will be receiving \$178,976 in Family First COVID Relief Act (FFCRA) and CARES Act funding for our services in Congregate and Meals on Wheels "Grab and Go" programs. This allocation is an increase of our original 2020/21 inter-governmental funding contract with Aging and Adult Services by \$35,296 in Congregate, additional \$20,250 for Meals on Wheels and \$30,646 for programs we were not contracted for—resulting in a total of \$86,192 additional funds.

Our regular Meals on Wheels clients are still being funded with Older American Act (OAA) funds and is not part of this funding. Other services which we were not in contract for but will be reimbursed for include our wellness calls, shopping assistance program, and our virtual classes. FFCRA and CARES Act funds can be used for fiscal year 2020-2021 and continue thru September 2021. If we fall short of funds in our Grab and Go programs by overserving our units of service we can then revert back to OAA funds to cover the shortfall (up to approximately \$37,000).

Efforts were made for an additional \$25,000 grant from Meals on Wheels America (MOWA), but was declined due to the number of applicants. This was the third round of COVID relief grants offered by MOWA. Pacifica had already received funds from the first two rounds—totaling \$22,800.

The Giving Tree program received donations of \$9,540 between the months of October - December

COVID-19 updates:

Age Friendly Cities (AFC) update

The City of Pacifica was recognized as one of the first three cities to be certified as an Age Friendly Community by the World Health Organization (WHO) during San Mateo County Supervisor David Canapa's county wide meeting in July. Roy Earnest, Pacifica's AFC Chair, represented Pacifica with a short presentation of our efforts—which included an update of our CaR Transportation program.

We have witnessed an increase in trips for medical appointments and number of rides. There are currently 264 Pacifica residents 65+ years old registered in the program since the roll-out November 4, 2019.

Senior Services Administration

Our vacant Transportation Specialist-"Class B" Bus Driver position remains open and recruitment will not start until we plan to resume our Transportation Services. This position will assume all transportation services operations--including the CaR program.

Building & Facilities

The new Community Center Playground is opened and being enjoyed by many with COVID protocols in place. New walkways and railings have been installed for ease and safe access.

A retaining wall with landscaping was constructed to brace the new walkway at the East end of the walkway by the entrance to the skate park is completed. Landscaping was part of the EQ Basin contract since existing landscape was removed for construction.

Programs & Activities (Submitted by Dana Dieterle, Program Coordinator)

Congregate "Grab and Go" Lunch Program

The "Grab and Go" lunch program continues to be a huge success. Along with the meals, efforts are made to distribute printed educational material pertaining to COVID-19, "brain teasers", as well as offer of books and jig saw puzzles. Senior Services staff dressed up for Oktoberfest, Halloween, and Santa Claus passed out Candy Canes for the Holidays!







Reimagining Programs

All in-house classes, programs, services, and activities continue to remain suspended (since March 16, 2020). Senior Services staff continue to strategize ways to reimagine programs. Pacifica Senior Services has created a Virtual Senior Center page to give seniors a nice way to get a break from their routine at home and keep them entertained. The Virtual Senior Center consists of URL links that will direct participants to fitness, puzzles, games, and more! The URL links are posted online at www.cityofpacifica.org/seniorservices and in the Senior Tidings newsletter. Currently, nine classes and services are being offered virtually through Zoom: American Line Dancing, Aerobics, Chair/Mat Yoga, Rosen Method Movement, Zumba Gold, "STAGES" Drop-in Discussion, Drop-in Grief Support, and Ukulele Class Jam Session. Virtual Bingo hosted by PB&R on Zoom is held weekly on Wednesdays at 3pm, and participation is steady averaging 10 people since we started this program in July. Senior Services staff continues Virtual Coffee Happy Hour via Zoom on Thursdays at 10am. This is a time to provide updates, conversation, reconnect, check in, and share a laugh.

Pacifica Senior Services has been working closely with the Sanchez Art Center, offering Pacifica Residents 60+ years old to take part in a short three month Creative Art Engagement program.

Believe it or not, anyone and everyone has an artistic side! Sanchez Art Center Executive Director, Cindy Abbott, has been helping distribute art kits during "Grab and Go" lunches, and is keeping on top of the Zoom meetings where participants can meet artist Lola Franknoi. This

wonderful program has been sponsored by Pacificans Care.





Pacifica Senior Services held an Outdoor Rummage Clearance Sale on October 24, 2020. The sale was held in the East Side Parking lot of the Pacifica Community Center. The idea of this event was to clear out storage space in the Community Center. We followed CDC rules, had a sanitation station, masks and social distancing were required, and one way foot traffic was enforced. Volunteers and staff helped set up, break down, and sell items fundraising \$1,661 for Senior Services in one day!









In October, Pacifica Senior Services promoted an at-home pumpkin decorating contest where seniors could transform a pumpkin into a "boo-tiful" Halloween decoration. Participants were welcome to paint, carve, or decorate a pumpkin. This activity was intended for folks to take a break from the news, and join in an activity they most likely haven't engaged in since they were young. There were 24 entries posted to the Pacifica Senior Services Facebook page, and the top three entries with the most 'likes' won a prize!









This year we honored and thanked our Veterans through sidewalk chalk art. Seniors were welcome to drop by the Pacifica Community Center to express their appreciation for our Veterans. The chalk walk was stationed in front of the Community Center on November 9th and 10th. We encouraged participants to bring their own chalk, however, we had chalk available while supplies lasted.





Due to the Volunteer Appreciation event being cancelled in April, Pacifica Senior Services staff decided to go through with a drive-thru Volunteer Appreciation on November 23, 2020. Volunteers received a Pacifica Senior Services tote bag, volunteer pin, certificate, and Edible Arrangement dessert. Volunteers who have put in 20+ years of service at our Center received a bouquet of flowers. This event was well attended, and efforts were made to make sure every single one of our volunteers have not been forgotten amid the pandemic. Our Center would not be able to operate our services without our volunteer's time, dedication, and support! We are so thankful to have our volunteers as part of our team.









Pacifica Senior Services staff "surprised" Recreation Manager, Jim Lange with a drive by retirement parade on December 17, 2020. Invitations were sent out to all SIA members and City staff. Approximately 120 vehicles lined up in Parking Lot C and paraded through the East Side parking lot of the Pacifica Community Center. While we miss Jim already- we wish him nothing but the best in this next chapter of his life!



The Holidays were celebrated a bit differently this year, but definitely still remembered. For Thanksgiving, we continued our annual Thanksgiving feast during "Grab and Go" which included: roast turkey with stuffing, mashed potatoes, green beans, toss salad, and a roll. Staff also surprised participants with pumpkin pie! Senior Services joined efforts with the PB&R Department for the Santa parade on December 5, and appreciated seeing several SIA members sitting curbside watching Santa drive-by neighborhoods in Pacifica. The same day as Jim's drive-by retirement parade, we also had our Holiday Luncheon advertised. Mrs. Claus made a special appearance, helped pass out meals, and added so much more excitement on top of the retirement parade. In addition, "Grab and Go" lunch was full of fun Holiday surprises on December 23. The luncheon unexpectedly changed to Prime Rib as a special Holiday meal for our "Grab and Go" participants. Food Coordinator, Steve Humphrey and SIA member, Tommy Lee sang some Christmas carols as cars drove by, and Santa came by for a special visit!









Senior Nutrition Programs (Submitted by Stephanie Coy, Community Services Coordinator)

Meals on Wheels (MOW)

- Meals on Wheels volunteers delivered 6,482 meals to our frail homebound clients enrolled in the MOW program and an additional 790 meals to seniors "Sheltered in Place" during the second quarter of 2020-21.
- Unduplicated clients were 128 homebound seniors (114 MOW clients + 14 "Grab and Go" delivered clients). Meals continue to be delivered fresh daily M-F and frozen meals for weekend and holidays delivered on Fridays or the day before the holiday.
- The average client donation for service is \$1.47 per meal.
- Our continued collaboration with students from the San Francisco State University School
 of Nursing was very successful. Although traditional home visits were not conducted, the
 nursing students completed 100% of the assessments due for this quarter over the phone.
 Client files are up-to-date and we received client feed-back that they appreciate the call
 from a nursing student.

- After having built out our 7th route last quarter, we continue to build out our substitute volunteer pool. We lost volunteers when COVID began (due to COVID), but we have recruited new volunteers. Our routes continue to be fully covered and reliant on committed volunteers.
 - We have 35 consistent volunteers who are assigned to a route and an additional 11 volunteers who are called upon to substitute.
- Meals on Wheels participated in the official 2020 Subaru Share the Love Event. Subaru and Meals on Wheels America partner annually to bring donations to various charities and organizations. We initiated a partnership with our local dealership, Carlsen Subaru in Redwood City to place Meals on Wheels City of Pacifica on a platform with an incentive to motivate car buyers to choose donations to go directly to us. We will submit our efforts in a proposal to Meals in Wheels America in January 2021 to increase our chances of receiving a higher donation amount for our participation in promoting the event.

Information & Referral Services (Submitted by Karen Parque, Information & Referral Coordinator)

Congregate (currently 100% "Grab and Go")

- "Grab and Go" drive-thru program has served 6,649 meals during the second quarter of 2020-21.
- There were approximately 74 unduplicated seniors picking up meals during the months October December.
- Fresh meals continue to be picked up M-F between 11:30am-12:30pm from the East driveway of the Community Center.
- Our Thanksgiving Feast was a big hit. We handed out 141 meals.

AARP TAX Services

Tax season prep is still not out of the picture for this coming tax season. Work is currently being done to organize a safe and heathy way to get taxes done.

Medical Supply Loan Program

The Medical Supply Loan Program is still ongoing, we provided 10 pieces of equipment.
 Due to COVID it's a little harder to get the equipment to our seniors, but we are making it work. Items loaned included canes, walkers, shower chairs, commodes and wheel chairs.

Shopping Assistance for Homebound Seniors (SASH)

SASH volunteers shop for homebound seniors in need of groceries and household supplies. We currently have 12 SASH clients and 5 SASH Volunteers. Our volunteers have been shopping for our clients once a week for the past 9 months.

CaR Program (Connect a Ride) update:

CaR ridership has begun increasing and expanding distance since the COVID-19 "Shelter in Place" began. We have witnessed an increase in trips for medical appointments as well as the overall number of rides. There are currently 288 Pacifica residents 65+ years old registered in the program since the roll-out November 4, 2019.
