CALL TO ORDER:

Chair Kellogg called the meeting to order at 7:00 PM.

I PLEDGE OF ALLEGIANCE:

III APPROVAL OF MINUTES:

Chair Kellogg called for a motion to approve the minutes of the 4-26-19 meeting.

Motion was made by Commissioner Abbott, seconded by Commissioner Cochran, motion carried 4-0. Commissioner Lusson abstained.

IV ADOPTION OF THE AGENDA:

Chair Kellogg called for a motion adopting the order of the agenda. Commissioner Knowles made a motion to accept the agenda, seconded by Commissioner Cochran, motion carried 5-0.

V INTRODUCTION OF NEW COMMISSIONER:

New Commissioner Nick Lusson was introduced.

Commissioner Lusson: shared that his family moved from San Francisco to Pacifica about a year ago. He works full time in youth soccer as director of Northern California Premier Soccer. It is the governing body for competitive soccer in Northern California. He also works with the Alameda Sheriff's office running a youth soccer program. He works with US Soccer training soccer coaches.

Chair Kellogg: welcomed Commissioner Lusson.

IX ITEMS FOR CONSIDERATION:

Commissioner Knowles asked to reverse the order of items A and B on the agenda. Motion was made by Commissioner Abbott, seconded by Commissioner Knowles, motion carried 5-0.

A) Bike Park Study Session Recap

Chair Kellogg asked for comments on the Bike Park Study session. **Commissioner Lusson:** felt that the Bike Park is an exciting vision and hopes there is a path forward and the staff and City Council point the group in the right direction to move the project forward.

Commission Abbott: reminded the commission that there are no formal minutes taken at a study session so it is not documented for the public. She asked for more information on community support. ?The Frontierland Park location has been considered for other projects in the past. She doesn't want to assume that everyone is behind the project. She agreed with Director Perez that a petition and later a more formal process like a survey is needed. Commissioner Cochran: would like to see another study session to get all the latest information and progress toward the next level. Other stakeholders could add information on maintenance.

Chair Kellogg: added to the record that there was a presentation from interested parties on the bike park at the study session. There are a lot of examples in the bay area that he thought were pretty nice. The bike park committee had indicated the size needed for the bike park and that the lower part of Frontierland was a possible location. Another study session with more information could help interested parties move forward and collect information the city council may want.

Commission Abbott: suggested an open house and asked if commission assignments could include an assignment for the Bike Park. **Director Perez:** shared that he will be redoing all of the commission liaison assignments. For the record he stated that both he and Anthony Schriver took notes at the study session. He will talk to the City Manager and see where he would like the project to go. Director Perez will report back at the next meeting.

Chair Kellogg: called for any comments the Bike Park Study Session from the public in attendance.

Matt McPhail: spoke regarding the Bike Park Study session. He thanked the commission and the City Council members that attended the study session for their time. He looks forward to working with them in

the future.

B) Input on Bicycle and Pedestrian "Draft" Master Plan Recommendations

Ryan Marquez, City of Pacifica Associate Civil Engineer presented a slide show about the Bicycle and Pedestrian "Draft" Master Plan. A copy of the printed presentation is attached to the minutes.

Ryan Marquez: He introduced himself as the Project Manager of the Bicycle and Pedestrian Master Plan. He explained that Pacifica does have a bike plan from 2000 which is severely outdated. They have been working with Alta Planning and Design the past year to develop a new and updated master plan. The purpose of his presentation was to update the commission and to answer questions and take comments from the commissioners on the Bicycle and Pedestrian "Draft" Master Plan they received prior to the meeting. He reviewed the goals of the plan:

- To address current and future Bicycle and Pedestrian improvement needs.
- To improve connectivity to key destinations and adjacent communities around Pacifica.
- To address present and future safety concerns for walking and biking.
- To prioritize future projects and assess the feasibility and cost effectiveness of those projects.

He requested that the commission members read the memorandum and review the figures in the document. He opened up for questions during the meeting. Once the Commissioners are done reading the package he asked them to submit either written or electronic comments to himself or Director Perez. He feels feedback from the Commission is very important to make sure they develop the best plan.

Ryan Marquez took the Commissioners through each slide in his presentation.

Commissioner Cochran: noticed on the Bike/Ped pathway that goes from Pedro Point over to Rockaway and Sharp Park that there are no speed limits posted. He feels that speeding bikers can create a hazard. Ryan Marquez commented that this was a good point and noted it.

Commission Abbott: appreciated the clear package they received and thanked them for the hard work. She asked if the website would again be open for public input. **Ryan Marquez** replied that the information presented was only for the commissioners. Online comments will reopen but with updated information. This is not the last chance people will have to comment. The commissioners have until July 24th to submit their comments.

Commission Abbott: Asked how the various projects would be prioritized. **Ryan Marquez** replied that this is a plan for both tomorrow and for 20 years. Some projects may be far down the line and some may be easy. Some projects may need Cal Trans sign off which can take several years. Projects will be prioritized by cost effectiveness and feasibility. There will be different weighted items used to prioritize the projects.

Commissioner Knowles: She plans to ride all of the streets to get a feel for the needs. She asked if there was a "road diet" proposed for the lower Linda Mar area. **Ryan Marquez** said yes they are looking at it. A constrained diet

is similar in that it also reduces lanes or space.

Commissioner Knowles: She commented that there needs to be public support to reduce lanes. In a Bike Boulevard she wanted to know if the biker could take the lane since it's not closed to cars. **Ryan Marquez** explained that the difference between the class 3 regular and the class 3 bike boulevards is the signage and the type of road. He said that some of the details in the plan will be clearer to see in the on line version.

Commissioner Knowles: feels this is a bright spot in the City of Pacifica. **Ryan Marquez** commented that they got great feedback and support from people at the Ecofest.

Commissioner Lusson: observed that one of the goals is prioritization of future projects. He asked if there is consideration of current hot spots with traffic flow and safety. **Ryan Marquez** replied that certain areas have been identified as potentially unsafe and will be pushed up the prioritization list.

Ryan Marquez: outlined the next steps for the project;

The project website is ready to move to the next public commenting phase. The website will be open for 2 months for public comment. Alta will continue doing public outreach. He reiterated that July 24 is the deadline for Commissioners comments. There will be more chances to make comments after that. In September there will be one more meeting/workshop. The commission will receive the full draft document at that time. The draft plan will be presented to the public. Finally, there will be one more meeting for Commissioners comments and approval. The plan then goes to City Council for their approval.

X REPORTS, ANNOUNCEMENTS, AND CORRESPONDENCE FROM COMMISSIONERS:

Commissioner Cochran: announced that the 20th annual Kahuna Kapuna surf contest at Linda Mar beach for older surfers will be July 13th. Lots of fun and raffle items.

Commission Abbott: The Library Advisory Committee made a presentation to the City Council. They shared the results of their public survey. The group will take another 6 months to share the plans for Sharp Park library and the open concept model for Sanchez with the community. They will attend the July 4th event at Frontierland Park to share the new library plans. June 14th she went with the age friendly task force to an event hosted by Supervisor Canepa along with others from San Mateo County. Pacifica had a large presence at the gathering and impressed the audience. Council Member Bier was one of the opening speakers. There is an art show coming up at Sanchez Art Center in coordination with the OPHT "Painting Along the Ohlone-Portola' Trail". This is part of the November OPHT celebration. The show opens July 12th. All the Art was painted locally. A reception, trail talk and workshop are all included. The show is sponsored by Don Horsley.

Commissioner Knowles: Pacifica Pedals the coast was May 11th. There were 12 participants. They hope to organize future events to get people more excited about biking Pacifica. The ride ended at Pedro Point Brewing Co, joining with the Pacifica Land Trust. Posters from the Bike and Ped

plan were exhibited.

Commissioner Abbott: noted that there was a conversation on the application "Next Door" about the swing set seats at Frontierland Park being cut. Public Works was able to fix them the same day which was a nice win. It was suggested that we consider a Friends of the Park or Park Champions program.

XI REPORTS FROM STAFF:

Director Perez reported on the following:

All the Commissioners are invited to the 45th Annual July 4th event at Frontierland Park. PBR will have a booth that day. The Library Committee will also attend and provide an activity.

Director Perez: suggested that we explore ways to get feedback from the seniors on the Bike and Ped plan.

At the June 24th Council meeting, **Director Perez** accepted the July is Parks Make Life Better proclamation, on behalf of the PB&R and Public Works departments and staff as well as the Commission - Commissioner Abbott was in attendance – Commissioner Knowles was at the meeting as well. Director Perez took the opportunity to thank Public Works, and highlight department programs and summer happenings.

Plan Pacifica. In early 2019 the City of Pacifica began the simultaneous process of updating its General Plan and Local Coastal Program, and developing a Specific Plan for the Sharp Park neighborhood.

The first of these meetings will occur Thursday evening, June 27, 6:00 pm at the Community Center at 540 Crespi Drive. The project site at planpacifica.org provides information about each project, including ways to participate, project documents and City contacts.

Director Perez attended a meeting earlier today to discuss the OPHT celebrations with Pacifica stake holders and the GGNRA. There will be a big event at the Community Center November 2nd along with several hikes, presentations and lots of activities.

New Commissioner

Director Perez welcomed our new commissioner, Nick Lusson. He and Commissioner Lusson met last month for an orientation.

Director Perez attended the Celebration for Age Friendly San Mateo County, hosted by Supervisor Canepa, on June 14th. Recreation Manager Jim Lange and Pacifica's task force member/Commissioner Cindy Abbott, gave the results

of Pacifica's focus group's work. Councilmember Mary Bier also spoke about Pacifica's work and progress. **Director Perez** is very proud of our city's progress and the contribution of our contingent.

The projects submitted to the World Health Organization on the application are:

- 1.) Housing: In partnership with local housing providers/advocates, host 3 "Affordable Housing Symposiums" that would provide information about the eligibility/application requirements for the four existing affordable senior apartment complexes in Pacifica, highlight shared housing options and explore other strategies for affordable housing.
- 2.) Transportation: In partnership with local transportation advocates, review innovative programs and use a variety of resources to launch a pilot transportation program to supplement existing options for transportation to reduce isolation and increase access to health and other services.
- 3.) Respect and Social Inclusion: In partnership with local Chamber of Commerce, recognize "Age Friendly Business" practices of local businesses and organizations and offer a training program to further encourage an Age-friendly awareness.

Budget

The budget was passed on Monday night, June 24th. As part of the City Manager's budget strategies and recommendations, the following relating to the PB&R department Staffing and Funding was included in the report: Last year the Council authorized beginning to use the Roy Davies Trust Fund for priority PB&R projects for which those funds are specifically designated. In addition to this funding source, PB&R also received a significant bequest this year, slightly under \$2 Million, for Senior Services. PB&R capital projects for FY2019-20 are recommended to be funded by these sources as allowed, thus relieving pressure on General Fund dollars while still accomplishing priority PB&R facility improvements.

Separate from these funding sources, the Childcare Program is experiencing a significant increase in demand, with all-time high waiting lists for childcare slots. In order to increase childcare capacity and serve more families, more teachers are necessary. PB&R staff is assessing options for fulfilling this need with financially sustainable changes to the program that do not impact the General Fund and yet enhance services to the public.

City Manager's Recommendation

Continue to use appropriate non-General Fund sources of funding for PB&R-related capital projects, and expand childcare services in a way that is financially sustainable and increases childcare capacity while not impacting the General Fund, details to be considered during FY2019-20 budget development. This includes hiring 5 Child Care full-time positions. (One site coordinator and four lead teachers). They are currently in the process of

interviewing candidates. The plan is to get everyone in place by August 1st. The cost will be covered by the 70 new students we can accept. Our adopted budget will be \$5,120,000 in expenditures and approximately \$4,429,000 in revenue.

Magical Bridge Playground - building innovative playground and more inclusive communities

Director Perez and Sam Bautista toured the Palo Alto park and found it amazing. Their mission is for everyone to experience the love of play and the joy of community connections. The playgrounds are mindfully designed to meet the needs of everyone. They collaborate with communities to gather insight and feedback, including from those with a range of disabilities, development experts, and of course, kids. A private company wants to build 5 of these parks. If Pacifica can provide a location they are interested in building one here. A suggested location might be by the Sanchez library.

New Mission

Director Perez announced the department's new Mission Statement. Working together to build a healthy, inclusive, connected, community through positive social and recreational experiences.

He also shared the new a tag line: Get Connected

 Adventure Camp, located at the Oddstad School campus, has three groups and runs Mon thru Friday. Our other Adventure Camp program is Fairmont Recreation Program located at Esther Hall Neighborhood Center, opening Monday, July 1st and runs through August 2nd

In an effort to help parents with the extended summer break this year; we have added a new camp "End of Summer Fun Dayz," the week of August 5th. This camp will be a joint venture of both Recreation and Aquatics and will combine the best of Adventure camp and Wet & Wild Water Camp

Director Perez: gave a special thank you to Ryan Marquez for his Bike and Ped presentation.

Director Perez asked that when people "see something they should say something", but that they need to talk to the right people. When the swings were damaged residents posted on social media, but no one called Public Works or PBR. If there is vandalism the police should be notified. If the commission is interested in pursuing a Park Champions plan we need to include public works.

Commissioner Knowles: asked if "adopt a park" was discussed back when the park inventories were discussed. **Director Perez** confirmed that it had been discussed. **Commissioner Knowles** said that seeing people step up to help with the swings made her think this could be an idea.

Subject: Appeal to Heritage Tree Removal Application No. HT-079-19

Background/Discussion:

On June 25 2019, Aaron Levensailor, applied for a permit to remove one (1) heritage Monterey Cypress (*Cupressus macrocarpa*) tree in front of the property located at 425 Brighton Road. The reasons stated for the proposed tree removal are:

- Tree damage to the sidewalk and driveway.
- Cause of personal injury and driveway visibility hazard.
- Unsightly due to required pruning.

In fiscal year 2016-17 the tree located at 425 Brighton Road was scheduled to be removed by the City of Pacifica Public Works Department. The removal was based on a recommendation provided by Tree Management Experts a tree consulting company contracted by the City of Pacifica. The City of Pacifica is currently working to address trees rated as medium-risk into order to ultimately create a low risk urban forest. This goal is to be accomplished by pruning, or in some cases, tree removal. The tree has been directionally pruned by utility contractors in order to achieve the required power line clearance. The utility pruning limits the options for improvement with additional pruning.

The City received complaints about the intended removal of this tree and opted to attempt to mitigate the trees structural problems with pruning. Attempted removals of this tree have been opposed in the past. After two consecutive pruning's the tree was determined by Tree Management Experts to now be a low-risk tree.

In June of 2019 Aaron Levensailar approached the City about obtaining a permit that would allow him to contract a private company to remove the tree. Mr. Levensailar had concerns about the tree and applied for a tree removal permit. City Staff denied the permit and scheduled a hearing for the July 24, 2019 meeting of the Commission. Notices were placed on the tree notifying interested parties of the upcoming hearing and informational letters were mailed to adjacent property owners.

Commission Action Requested:

Commission is requested to approve, disapprove or modify the decision of City Staff denying the application for the removal of the tree.

An application has been submitted to remove this heritage tree under the provisions of the City's Heritage Tree Ordinance (Chapter 12, Title 4, of the Pacifica Municipal Code). A heritage tree is defined as a tree, exclusive of Eucalyptus, which has a trunk circumference of fifty (50") inches (approximately sixteen (16") inches in diameter or more), measured at twenty-four (24") inches in diameter or more), measured at twenty-four (24") inches above the natural grade, or a tree or grove of trees including Eucalyptus designated by resolution of the city Council to be a special historical, environmental or aesthetic value. No person may trim, cut down, destroy, remove, or move a heritage tree for which a permit application is in process.

A person violating any of the provisions of the Heritage Tree Ordinance shall be guilty of a misdemeanor and shall be subject to a fine of up to \$1,000 or six months imprisonment, or a combination thereof, and may be subject to administrative civil penalties as provided by the Municipal Code.

The permit to remove of the tree has been denied by the City of Pacifica Public Works Department and this decision has been appealed. The matter concerning the removal of this tree will be heard and a decision will be made at the regular monthly meeting of the City of Pacifica Parks Beach and Recreation Commission. All of the concerned parties will be allowed to present their opinions on the matter at this time. This meeting is scheduled for July 24,2019 at 7:00 PM. The meeting will be held at the City Council Chambers located at 2212 Beach Boulevard, Pacifica CA.

On the following pages you will find information on our most recent quarter of programs and events, put together by department staff. As always I would like to that our staff for all their hard work and efforts in delivering services to the community as well has putting together our plans an schedule for the next three months. Summer is not more than halfway over, with classes and events happening throughout the department. In August programs will begin to slow down and eventually end as much of our summer staff and participants go back to school. In October we will have quarterly reports which will include a full recap of summer activities.

PLAY

Editor in Chief and Recreation Assistant Supervisor Phipps sent the finished copy of the Fall PLAY to the printers last week. with the final product scheduled to be delivered to the printer on July 23rd. It will be mailed out to Pacifica residents the first week of August and registration for Fall classes and activities begins on August 15th.

Ohlone-Portola' Heritage Trail (OPHT)

This is the 250th anniversary commemorating the sighting of San Francisco Bay by the Portola' Expedition in 1769 and of the Ramaytush Ohlone people who greeted them warmly.

In June there was a meeting of the Ohlone-Portola' Heritage Day Planning Committee. PB&R Director, along with the OPHT core Pacifica members, San Mateo County Planner Herzberg, members of the Pacifica Historical Society and GGNRA staff members met to discuss the events happening on November 2nd, the Ohlone-Portola' Heritage Day, at the Pacifica Community Center. Last week another planning meeting was held, which focused on connecting with partners and putting together the ceremony and events of the day.

BPAC

Following last month's meeting's Bike and Ped Master Plan draft recommendations presentation, commissioners were sent a follow up email.

Those draft recommendations for Pacifica's Bicycle and Pedestrian Master Plan were released for public comment on the project website, WalkBikePacifica.com. Commissioners were asked to visit the website and use the interactive input map to view the details on the draft recommendations, "Like" or "Dislike" certain recommendations, and offer comments on the proposed network of bicycle and pedestrian improvements. The website will remain open throughout the remainder of the summer and will close for public comments on September 4, 2019.

We are planning on having the consultants attend our September meeting to hold a workshop similar to the one earlier this year and to present the draft plan.

Bike Park

Last month the Pacifica Bike Park committee presented their plans and initial proposal for a bike park in Pacifica during a study session prior to the regular Commission meeting. Commissioners asked questions and gave feedback to the group, who are working to answer those questions and address concerns. Director Perez is discussing next steps with the City Manager, which may include another meeting with PB&R and the Bike Park group and/or a joint PB&R City Council study session.

Staff Updates

As you will see in our Child Care Division update, we are continuing to move forward with the hiring of five new full-time positions as part of a plan to address increased enrollment demands and to expand our capacity. We are planning to have three of the five positions filled by the end of July, with the other two filled in August.

CPRS "50 Over 50!" and "30 under 30!"

The California Parks and Recreation Society (CPRS) State Board of Directors is highlighting 50 professionals over 50. CPRS members were asked to nominate outstanding professionals over the age of 50, who would share their story and passion for the Parks and Recreation profession. Nominees were asked to write a brief testimonial to share experiences in the field, lessons learned and/or what parks and recreation has done for them. These testimonials, along with participant biographies, will be posted on social medial, the CPRS website, newsletter, and printed in the CPRS magazine throughout the year.

Subject: CHILD CARE PROGRAM UPDATE April-June 2019

Program Update

The Child Care division attended an in-service training in June. During this training, participants discussed 21st Century Strategies to Support Boys: Reducing and Eliminating Suspension and Expulsion as Options. Participants explored the link between traditional educational systems and the preschool to prison pipeline. Specifically, participants discussed which strategies strengthen and sustain young boys learning, growth and development for whole school readiness.

Over 30 Child Care employees attended this training. Participants who attended the training 'clocked' 4 hours of professional development to add to their Professional Growth Plan & Record. Child Care employees that hold a Teaching Permit from the Commission on Teacher Credentialing must clock a minimum of 105 hours of professional development to renew their permit for an additional 5 year period.



Summer 2019

The summer 2019 is shaping up to be one of the busiest seasons in the Child Care division. The division has experienced an increased demand for service and all-time high waiting lists for available slots. In order to accommodate the need for increased enrollment, to address the waiting lists, as well as to bolster our staffing situation, five new positions will be filled in 2019/2020. These positions will allow us to meet and/or increase our ability to serve our licensed capacity at each center.

In addition, staff has found a way to increase site capacity without increasing facility space. The existing full-day preschool program located at Vallemar will be relocated to the Fairmont Park site. This will increase both the usage of our City-owned facility (Fairmont) and the preschool program's capacity by moving to a larger facility. The half-day preschool program at Fairmont Park will be moved to Vallemar. This would open up a whole classroom for after-school care at Vallemar while addressing that site's waiting list by increasing our enrollment by up to 30+children.

During the summer of 2019 all four school-age programs will be operating: Sunset Ridge, Cabrillo, Ocean Shore and Vallemar and two full day preschool programs open at Fairmont West and Vallemar. There are weekly themes and special site events taking place throughout the summer, including the annual "Wild Animals" assembly, several walking trips that include the Pacifica Farmer's Market, the beach and to Seabowl as well as local nature field trips. There will also be Child Care field trips to the Cull Canyon East Bay Regional Park and to the USS Hornet in Alameda.

The Child Care and Recreation divisions have teamed up again to offer additional summer options for Child Care children - summer recreation trips; with pick-up points at both Vallemar and Fairmont Park (near the Sunset Ridge site) and week-long swim lessons through the Aquatics division; with pick-up and drop-off service by Child Care staff. Child Care is once again partnering with the Leaders in Training Education (LITE) program for the 17th summer. LITE volunteers have been assigned to all four Child Care school-age summer locations and will be involved with sports, games, arts and crafts, and summer trips.

Pacificans Care Summer Scholarships



For the 12th year in a row the PB&R Department is offering summer scholarships to all the subsidized children in the Child Care program. There is a total of \$7,000 in scholarships and this summer qualified families can apply for \$100 scholarships per child. Children may attend the out-of-town summer trips or take free swim lessons at Brink Pool throughout the summer. Scholarships can also be used for teens to take part in the summer LITE program. These scholarships were also made available to children in the community at large that qualify for the program who do not attend Child Care programs. These opportunities are made possible through funds donated by Pacificans Care.

Cabrillo and Vallemar After-School Programs

The Cabrillo and Vallemar After-school Program is open Monday, Tuesday, Thursday and Friday from 3:00-5:30pm and Wednesday 1:45-4:15pm during the school year. The activities and trips planned by the Recreation Staff are geared to allow the participants to be able to express their sense of self and remain physically and emotionally energized. There were 15 Cabrillo and 33 Vallemar students registered during the last two months of the school year. Both Cabrillo and Vallemar programs will start back up September 2019. Staff is working with Pacificia School District on a potential new location for the Cabrillo program, as the portable currently used will (most likely) be used for the Child Care expansion.

J-Teen Dances

J-teen dances are held at the Community Center one Friday a month from 7:00 to 9:00 PM during the school year. These dances are one of the few opportunities for Pacifica middle school youth to socially interact with students from other schools. Appropriate current music is provided by Party DJ. The dances are supervised by PB&R Recreation staff. Our last dance for the school year took place on Friday, May 17, 2019, and had an attendance of 164 students.

SUBJECT: SENIOR SERVICES DIVISION UPDATE April - June 2019

Manager's Report

Federal Older American Act Funding

Fiscal year closeout have been submitted to Area Agency on Aging for our programs that receive partial support from Older American Act funds. These programs include our Transportation, Congregate Nutrition and Meals on Wheels programs. These funds, along with State and County General Funds support, totaled \$225,950. For fiscal year 2019/20 we have been granted \$223,840 for the same programs.

Giving Tree Trust Funding

Giving Tree contributions totaled \$11,915 for fiscal year 2018/19. Since its creation in 2005/06, we have received \$159,000. Over the years we have spent \$67,000 in program and facility enhancements. Some of the major projects have included: Marque on the Community Center exterior wall, Bocce Ball Court construction, AV equipment in Auditorium, Gift Shop renovation, Computer Lab upgrades, exercise equipment, ping pong tables, small activity amenities and upcoming software program for capturing activities, volunteers and various other reporting data. Staff is currently working with a sound engineer to install a new system in the Auditorium.

Sirkka Niukkanen Bequest

Approximately \$2 million dollars has been received by Senior Services with the purpose of adding new programing for seniors in Pacifica. Manager Lange is looking into a new transportation program to address 24/7 accessibility to partial subsidized cab rides for shopping, medical appointments and local outings. Larger trips with a tour company are also being considered to promote socialization. Manager Lange has teamed up with former PB&R Commissioner and current San Mateo County Commission on Aging—Transportation Chair, Michael Mau, to work on this endeavor. Both have contacted outside agencies and vendors to discuss the possibilities of a program that would benefit our senior community critical needs. This would most likely include working with a cab company to provide this service 24/7 for seniors to get a ride anywhere in Pacifica, Colma Bart Station and neighboring healthcare facilities. Details are still be calculated and negotiate. The program will need to be approved by Pacifica City Council during a future date (TBD).

Pacificans Care 2019/20 Annual Grant

Manager Lange presented an annual grant request to Pacificans Care for the amount of \$20,000. The request was for continued general program support, meaning, to be used across all of our programs since they are all co-dependent upon each other.

Age Friendly Cities Initiative (AFCI)

Manager Lange and PB&R Commissioner (both AFC Task Force members) presented to approximately 150 neighboring city representatives Pacifica's Age Friendly Task Force three projects submitted to the World Health Organization for consideration for Pacifica to move forward in the process of becoming a certified Age-Friendly designated city.

- Pacifica, Redwood City and Daly City were the first three cities to be considered for this initiative in San Mateo County
- Colma, San Mateo and Foster City are the next three cities in San Mateo County to begin the process.
- It is the County Supervisors intention to get all cities in San Mateo County certified with this status.
- Pacifica's three projects submitted are:
 - 1. Host *three housing symposiums* (objective: provide seniors with information on a variety of housing options).
 - 2. Launch pilot program to provide *affordable local rides* for seniors (objective: overcome lack of transportation options in Pacifica and reduce isolation and increase access to services and social programs).
 - 3. Celebrate *age-friendly practices of local businesses and organizations* (objective: encourage further age-friendly actions through ongoing training and recognition).

Senior Services Administration

Manager Lange has moved forward with a new software program (Senior Space), in efforts to simplify data collection processes and free staff with more direct service time. Asst. Supervisor Cooney was critical in the process of getting data to the vendor in a correct format for setup of new system and forward thinking on the implementation process.

MISC. ADMINISTRATION

Manager Lange will be attending the annual Meals on Wheels Conference in August.

Building & Facilities

- The EQ Basin Project is moving along with the roof installation underway and outlet pipe alongside East Community Center driveway to Crespi.
- Safety rails were installed at the Bocce Ball Court, and some maintenance painting took place.
- Replacement marque was installed and put into operation in June. New sign has many upgrades from the former one.
- The Community Center is being considered by the Pacifica Beautification Committee to have a mural put on the north/west corner. Considerations are very preliminary—the suggested theme is of the Ohlone-Portola' Heritage Trail.

- *Live entertainment* is provided by guitarists and vocalists Scott Hill and Gene Gibson, Jr. who bring their magic to the Center every month as does DJ Rey Hauser.
- *Thursday Matinees* are held at the Pacifica Senior Center weekly. Movies start at 1:00 pm in the Portola Room. Fresh popcorn and iced water are provided.
- *Billiards* is back! Seniors are welcome to play pool at the Pacifica Community Center every Tuesday from 9:00 am 12:00 pm in the Game Room. Playing pool is a great way to socialize and meet friends.
- Technology and computers are everywhere today and it can often be intimidating to seniors. The *Computer Lab* is a friendly place where seniors can take their time, learn at their own pace, and gain a level of comfort with computers and technology. The volunteer instructors are active and eager to help seniors with all of their computer and handheld electronic needs. Senior Services offers computer classes every day of the week and the Computer Lab is now open all day on Wednesdays.
- In keeping with our mission, Senior Services' staff focus on lifting the voices of our seniors. On April 25, 2019 volunteers Herta Baxter (in her 20th year of service) and Dot & Mel Bolton accepted the 2018 "People Who Care Award" presented by Pacificans Care board member (and MOW volunteer) Joyce Robison. This is a tremendous honor which everyone involved with Pacifica Meals on Wheels greatly appreciates.

Pacifica Meals on Wheels completed its 6th semester this quarter in partnership with San Francisco State University School of Nursing Lecturer Lisa Marlowe, MSN and her students. As part of their Community Health field study, the students work in pairs to conduct MOW client eligibility intakes and re-assessments during home visits. In the process, they also identify critical unmet needs, address pressing issues and provide linkages to appropriate senior-serving agencies. In addition to the students, we are recruiting

retired registered nurses to offer the highest quality home visits between semesters. We welcomed volunteer Brigid Voss, RN into this role this quarter. Together, the students, Brigid, Assistant Supervisor Cooney and Information & Referral Coordinator Parque complete approximately 400 intakes and assessments per year (over 550 hours a year) as mandated by our Older American Act funding.

- Beth Bashore, MFT from Mission Hospice & Home Care is doing wonderful work with the *Drop-in Grief Support Program*.
