

RESOLUTION NO. 27-2022

A RESOLUTION OF THE CITY OF PACIFICA AUTHORIZING AND DESIGNATING THE CITY MANAGER OR CITY ENGINEER TO ACCEPT INTERESTS IN REAL PROPERTY ON BEHALF OF THE CITY

WHEREAS, California Government Code Section 27281 provides that deeds or grants conveying interests in real property to a governmental agency for public purposes will not be accepted for recording absent a certificate or resolution of acceptance by the governing body of the entity attached to the document;

WHEREAS, Section 27281 further provides that a governmental agency may, by resolution, designate an officer to accept and consent to such deeds or grants on behalf of the agency; and

WHEREAS, the City of Pacifica anticipates that it will receive transfers of easements and other real property in connection with its activities and desires to designate the City Manager or the City Engineer as the officer to accept such real property interests on behalf of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pacifica that:

1. The City Council hereby approves, authorizes and designates the City Manager or City Engineer, or his or her designee, as the officer to accept conveyances of real property on behalf of the City of Pacifica pursuant to the terms of California Government Code Section 27281.
2. The City Manager or City Engineer, or his or her designee, is authorized to execute certificates of acceptance accepting interests in real property to be recorded.
