**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA
APPROVE AMENDMENT TO CONSULTANT SERVICES AGREEMENT BETWEEN
THE CITY AND TERI BLACK & COMPANY, LLC., TO CONTINUE PROVIDING
EXECUTIVE RECRUITMENT SERVICES**

WHEREAS, Article 4, Section 2-4.401 of the Pacifica Municipal Code establishes a civil service personnel system and procedures for the administration of personnel matters; and

WHEREAS, the City entered into an agreement with Teri Black & Company, LLC under the City Manager's authority to conduct recruitment services for the Deputy Director of Public Works (Wastewater) in May 2022; and

WHEREAS, the Chief of Police position will become vacant on July 1, 2022, creating a critical need for the additional executive recruitment services; and

NOW, THEREFORE, be it resolved by the City Council of the City of Pacifica, California, to authorize the City Manager to amend the existing contract with Teri Black & Company, LLC., to execute necessary amendments with not to exceed the budget authority of \$63,400.
