

**RESOLUTION NO. 77-2020**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA DECLARING THE  
CANVASS OF RETURNS AND RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD  
ON NOVEMBER 3, 2020**

---

**WHEREAS**, a consolidated general municipal election was held and conducted in the City of Pacifica on the 3rd day of November, 2020, as required by law; and

**WHEREAS**, the election of candidates to the following seats: Member of City Council – District 1 (one seat) for a full term of four years and Member of City Council – District 4 (one seat) for a full term of four years were placed on the November 3, 2020 Official Ballot; and

**WHEREAS**, no local measures were placed on the November 3, 2020 Official Ballot for the City of Pacifica; and

**WHEREAS**, notice of the election was given in time, form and manner provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns were made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, California Elections Code provides that for a consolidated election, the City Clerk, upon receipt of the results of the election from the elections official conducting the election, shall certify the results to the governing body; and

**WHEREAS**, on December 3, 2020, Mark Church, Chief Elections Officer & Assessor-County Clerk-Recorder, caused to be filed with the City Clerk of the City of Pacifica the final certification in connection with the subject election which includes the record of votes from the canvass of all ballots cast at said General Municipal Election; and

**WHEREAS**, a copy of the final Certification is attached hereto as “Exhibit A” and incorporated herein by reference; and

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PACIFICA DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

SECTION 1. That the whole number of votes cast in the City of Pacifica District 1 was 3,932 and the whole number of votes cast in the City of Pacifica District 4 was 5,302 as set forth in “Exhibit A”.

SECTION 2. That the names of the persons voted for at said municipal election for the offices indicated and the total number of votes given in the indicated District in the City of Pacifica to each candidate, as shown on “Exhibit A”, are as follows:

Member, City Council, District 1:

Sue Vaterlaus	1,685 votes
Mayra Espinosa	1,666 votes

Member, City Council District 4:

Tygarjas Twyrles Bigstyck	1,864 votes
Mike Cohen	1,767 votes
Marj Davis	1,203 votes

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates is provided as set forth in "Exhibit A".

SECTION 4. The City Council does declare and determine that Sue Vaterlaus and Tygarjas Twyrles Bigstyck received the highest number of votes cast for the office for which each was a candidate and are thereby declared elected to said respective City Council offices for terms ending November 2024 (full four-year term).

SECTION 5. The City Clerk shall enter on the records of the City Council of the City of Pacifica, a statement of the result of the election in conformance with this Resolution showing: (1) The whole number of votes cast in each District in the City for which the election of an eligible office was conducted; (2) the names of the persons voted for; (3) for what office each person was voted for; and (4) the total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that to each person elected the Oath of Office shall be administered as prescribed in the Constitution of the State of California; and that each and all of the persons so elected shall be inducted into the respective office to which they have been elected.

SECTION 7. That the City Clerk shall certify the passage and adoption of this resolution and enter it into the book of original resolutions.
