A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA ACCEPTING THE REPORT OF SEWER SERVICE CHARGES FOR FISCAL YEAR 2019-2020 AND DIRECTING THE FILING OF CHARGES FOR COLLECTION BY THE COUNTY CONTROLLER

WHEREAS, pursuant to Section 6-6.502 of the Pacifica Municipal Code and Section 5473 of the California Health & Safety Code, the City has received a report of sewer charges for Fiscal Year 2019-20, computed in conformity with the City's schedule of sewer charges ("Report") is on file in the Office of the City Clerk and available for public inspection and is incorporated herein by reference; and

WHEREAS, the City Council desires to approve the Report and to submit the charges described therein to the San Mateo County Controller for collection on the 2019-2020 tax roll.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby approves the Report as submitted, and

BE IT FURTHER RESOLVED that the City Clerk is hereby instructed and authorized to transmit the Report to the County Controller and to file the necessary documents with the Controller to ensure that the said fees will be included on the County Tax Roll for Tax Year 2019-2020.



SEWER SERVICE CHARGES FOR FY 2019/20

Adopted FY 2019-20 \$16.43264/100 cubic feet of water consumption (Maximum increase of 8%)

<u>CALCULATION YEAR (March of the previous year thru February of the current year):</u> March 2018 thru February 2019	
<u>MEASUREMENT PERIOD USED FOR RESIDENTIAL CUSTOMERS:</u> Water billings from March 2018 thru February 2019.	
<u>RESIDENTIAL CALCULATION:</u> Actual Annual Water Consump. x 90% x \$16.43264=Sewer Service Charge	
<u>MINIMUM RESIDENTIAL SEWER SERVICE CHARGE:</u>	
48 Annual Units of Water Consumption x \$16.43264	= \$788.77
Prior year minimum charge	= \$730.34

<u>MEASUREMENT PERIOD FOR COMMERCIAL CUSTOMERS:</u> Actual Annual Water Consumption.	
<u>COMMERCIAL CALCULATION:</u> Actual Annual Water Consump. x \$16.43264 x strength factor = Sewer Service Charge.	
<u>COMMERCIAL STRENGTH FACTORS:</u>	
Car Washes	0.90
Cleaners	1.20
Laundromats	0.75
Restaurants with functioning grease traps	1.60
Restaurants without functioning grease traps	1.80
Gymnasiums	0.90
Any other commercial use	1.00

Section 6-6.401 through 6-6.407 of the Pacifica Municipal Code addresses the assessment of Sewer Service Charges including the rate and the measurement periods for both residential and commercial customers.
