COMMISSION COMMENTS:

Commission Chair Hladky spoke about his experience at the County Disaster Preparedness Day event. He also spoke about two emails he received from community members. One email involved building a fence on private property, and the other the removal of a whale carcass. Both emails were sent to city staff.

Commissioner Crawford spoke about his experiences the County Disaster Preparedness Day event. He praised staff for their efforts to organize the City of Pacifica table at this event, and spoke about the variety of quality materials available.

Commissioner Johnson apologized for missing the Disaster Preparedness Day event.

COUNCIL LIASION COMMENTS:

Mayor Pro Tem Bigstyk spoke to the commission on several topics. He spoke about the General Plan update that had been passed by City Council. He pointed out the plan was last updated 42 years ago, and praised staff for their work on the project. He also shared the Plan would be reviewed at the Council goal setting session in February 2023. Mayor Pro Tem Bigstyk also spoke about the Pacifica Safe Parking Program, the City housing plan, and the waste water treatment plant's (WWTP) new ultra-violet light project intended to extend the service life of the WWTP. He also spoke about the Local Roadway Safety Plan (LRSP) which is being overseen by Public Works Deputy Director Bautista. He pointed out community members had recently shared concerns about speeding on Fassler Ave. and Manor Dr. and he anticipated the plan would help address traffic safety concerns throughout the City. Deputy Director Bautista is the point of contact for this project.

Mayor Pro Tem Bigstyk responded to questions from commissioners about the city housing plan and state mandates to increase housing in the city. He also spoke about upcoming Fog Fest on September 24 and 25.
