**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA  
AUTHORIZING THE CITY MANAGER TO EXECUTE A THIRD AMENDMENT TO  
THE CONSULTANT SERVICES AGREEMENT WITH GOOD CITY COMPANY  
FOR PROFESSIONAL PLANNING AND RELATED SERVICES.**

**WHEREAS**, consistent with the City of Pacifica's Purchasing Policy (Administrative Policy No. 76), the City of Pacifica entered into an agreement with Good City Company for consulting services under the City Manager's purchasing authority in October 2020; and

**WHEREAS**, the City Council authorized amendments to the City's agreement with Good City Company for consulting services on November 2021 and June 2022; and


**WHEREAS**, the City Council of the City of Pacifica has considered the City Manager's recommendation to approve a third amendment to the City's agreement with Good City Company for consultant services on September 26, 2022.

**NOW, THEREFORE BE IT RESOLVED** by the City Council of the City of Pacifica to authorize the City Manager to amend the agreement with Good City Company for the purpose of increasing the cost ceiling to an amount not to exceed \$320,000 and extending the term of the contract through June 30, 2024.
