Inspector Ryan Adams from the North County Fire Authority (NCFA) spoke to the Commission regarding fire mitigation and the grant funded chipper program. The Coastal Conservancy grant for \$130,000 was awarded in 2021 to the City. Inspector Adams presented a slide show with before and after photos documenting the reduced vegetation in neighborhoods. There is another upcoming opportunity for community members in the designated neighborhoods to take advantage of this program in November. The final operation under this grant will take place November 7-11, 2022. The NCFA and City have again applied for this grant through the Coastal Conservancy. Additional
