

RESOLUTION NO. 88-2022

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA DECLARING THE
CANVASS OF RETURNS AND RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD
ON NOVEMBER 8, 2022**

WHEREAS, a consolidated General Municipal Election was held and conducted in the City of Pacifica on the 8th day of November, 2022, as required by law; and

WHEREAS, the election of candidates to the following seats: Member of City Council - District 2 (one seat) for a full term of four years, Member of City Council - District 3 (one seat) for a full term of four years, and Member of City Council - District 5 (one seat) for a full term of four years were placed on the November 8, 2022 Official Ballot; and

WHEREAS, two local measures were placed on the November 8, 2022 Official Ballot for the City of Pacifica; and

WHEREAS, notice of the election was given in time, form and manner provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns were made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, California Elections Code provides that for a consolidated election, the City Clerk, upon receipt of the results of the election from the elections official conducting the election, shall certify the results to the governing body; and

WHEREAS, on December 9, 2022, Mark Church, Chief Elections Officer & Assessor-County Clerk-Recorder, caused to be filed with the City Clerk of the City of Pacifica the final certification in connection with the subject election which includes the record of votes from the canvass of all ballots cast at said General Municipal Election; and

WHEREAS, a copy of the final Certification is attached hereto as "Exhibit A" and incorporated herein by reference; and

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PACIFICA DOES
RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

SECTION 1. That the whole number of votes cast in the City of Pacifica District 2 was 2,834; the whole number of votes cast in the City of Pacifica District 3 was 3,609; the whole number of votes cast in the City of Pacifica District 5 was 3,872; the whole number of votes cast for Measures submitted to the qualified electors in the City of Pacifica was 16,678 as set forth in "Exhibit A".

SECTION 2. That the names of the persons voted for at said municipal election for the offices indicated and the total number of votes given in the indicated District in the City of Pacifica to each candidate, as shown on "Exhibit A", are as follows:

Member, City Council, District 2:

Robby Bancroft	1,063 votes
Christine Boles	1,496 votes

Member, City Council District 3:

Mary K. Bier	2,527 votes

That the Measures voted upon at said municipal election are as follows:

Measure Y voted on at said General Municipal Election read as follows:

“Shall the measure establishing a ½ ¢ sales tax for general government use to maintain the City of Pacifica’s vital services, such as police, fire, medical 9-1-1 emergency response; keeping pollution / trash off beaches; attracting / retaining jobs/businesses; street paving; storm drain maintenance to prevent flooding; preventing coastal erosion, and generating approximately \$2,600,000 annually for 9 years, with regular financial audits, independent citizens’ oversight, and requiring funds be used locally, be adopted?”

That the record of votes cast at said General Municipal Election for and against Measure Y, as shown on Exhibit A attached hereto, was: 9,577 YES; and 6,554 NO; and that a majority of all votes cast on Measure Y were in favor of said measure and said measure passed.

Measure Q voted on at said General Municipal Election read as follows:

(Advisory Vote Only) The City of Pacifica Sale and Use of Fireworks Advisory Measure. Shall the City of Pacifica amend its municipal code to prohibit the ignition, use, discharge, or sale of all State-approved “Safe and Sane” fireworks in the City of Pacifica?

That the record of votes cast at said Consolidated General Municipal Election for and against Measure Q, as shown on Exhibit A attached hereto, was: 6,747 YES; and 9,015 NO; and that a majority of all votes cast on Measure G were against said measure.

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates is provided as set forth in “Exhibit A”.

SECTION 4. The City Council does declare and determine that Christine Boles, Mary K.

Bier and Sue Beckmeyer received the highest number of votes cast for the office for which each was a candidate and are thereby declared elected to said respective City Council offices for terms ending November 2026 (full four-year term).

SECTION 5. The City Clerk shall enter on the records of the City Council of the City of Pacifica, a statement of the result of the election in conformance with this Resolution showing: (1) The whole number of votes cast in each District in the City for which the election of an eligible office was conducted and whole number of votes cast in the City; (2) the names of the persons voted for; (3) the measures voted upon; (4) for what office each person was voted for; (5) the number of votes given at each precinct to each person, and for and against each measure; and (6) the total number of votes given to each person, and for and against each measure.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that to each person elected the Oath of Office shall be administered as prescribed in the Constitution of the State of California; and that each and all of the persons so elected shall be inducted into the respective office to which they have been elected.

SECTION 7. That the City Clerk shall certify the passage and adoption of this resolution and enter it into the book of original resolutions.



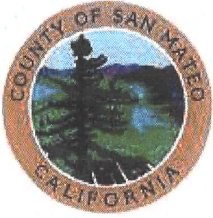
