A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA APPROVING AGREEMENTS FOR THE PURCHASE OF CITY REPLACEMENT VEHICLES PHASE 1 FOR FISCAL YEAR 2022-2023

WHEREAS, the City Council during their regular meeting on November, 28, 2022, adopted Resolution No. 82-2022 which approved a budget of \$1,979,660 and to purchase the following vehicles that are considered critical for replacement for Fiscal Year 2022-23; and

WHEREAS, the City maintains a fleet of vehicles and trucks. Vehicle replacements are primarily funded from Fund 72 - Motor Pool Replacement Fund; and

WHEREAS, the City desires to purchase vehicles from the Vehicle Replacement Fund 72 for immediate urgent needs; and

WHEREAS, the City used the State Contract and Sourcewell CA State Contract as procurement methods in which certain items, such as vehicles, have been negotiated to lower prices that regular retails prices;

NOW, THEREFORE, THE CITY COUNCIL HEREBY RESOLVES:
