

RESOLUTION NO. 54-2023

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA
APPROVING THE PURCHASE AGREEMENT BETWEEN THE CITY OF PACIFICA AND
MISCOWATER FOR THE PURCHASE OF SMITH & LOVELESS SCHLOSS BAR SCREEN
UNIT (REBUILD) FOR THE ROCKAWAY PUMP STATION BAR SCREEN REBUILD
PROJECT**

WHEREAS, during the FY 2022-23 Capital Improvements Program (CIP) budget approval process, the City Council approved funding for the Rockaway Pump Station Bar Screen Rebuild Project (Project); and

WHEREAS, the Project includes the Purchase and Installation of Smith & Loveless Schloss Bar Screen Unit (Rebuild); and

WHEREAS, the existing screening system at the Rockaway Pump Station includes (1) Smith & Loveless Schloss bar screen unit which was originally installed in 1996 and has now reached the end of its performance life and needs to be rehabbed; and

WHEREAS, Smith & Loveless, Inc. is the sole manufacturer of the Smith & Loveless Schloss bar screen unit and the exclusive source for service parts and appurtenances; and

WHEREAS, MISCOWater is the exclusive Smith & Loveless Schloss representative for California; and

WHEREAS, rebuilding the bar screen unit is more economical and effective compared to purchasing a different bar screen unit from a different manufacturer which will need reconfiguration of the well, will need more funding, and will run the risk of not having a working bar screen because of time delay; and

WHEREAS, purchasing the above equipment will reduce the complexity of Operations & Maintenance requirements due to the commonality of equipment already on-site; and

WHEREAS, because of the above reasons, the purchase and Installation of Smith & Loveless Schloss Bar Screen Unit (Rebuild) from MISCOWater have been determined to be sole source commodities and benefits the City; and

NOW, THEREFORE, THE CITY COUNCIL HEREBY RESOLVES:

The City Council of the City of Pacifica hereby approves the Purchase Agreement between the City of Pacifica and MISCOWater, via sole source, in the amount of \$162,344 for the purchase of Smith & Loveless - Schloss bar screen rebuild unit for the Rockaway Pump Station.


