Action Minutes

In attendance was Chair Patton, Co-Chair Arnos, McDermod, Goodmiller, Lancelle, Cardona, Skaggs and Read. Natesan was absent. Council Liaison/Mayor Bigstycyk Bigstycyk, and Staff Liaison Lin were also present.

CALL TO ORDER: *Chair Patton* called the meeting to order at 6:02 pm.

ADMINISTRATIVE BUSINESS:

Roll Call A quorum was confirmed.

Approval of Order of Agenda. Unanimously approved.

Approval of Minutes of April 19, 2023 Unanimously approved.

PUBLIC COMMUNICATIONS:

Oral Communications – None.

Committee Communications – *Patton* shared feedback from the Preservation Award council meeting, and thanked *Skaggs* for attending.

INFORMATIONAL ITEMS:

1. **Update by GGNRA/GGNPC** – *Sue Gardner* introduced as GGNPC staff and provided background on community engagement and stewardship with the program. Shared experience about the experience and conditions at Mori Point. *Darren Brown* provided updates on the Rancho Plan.
2. **Update by City Council Liaison/Mayor Bigstycyk** – *Council Liaison/Mayor Bigstycyk Bigstycyk* provided updates to the last City Council meeting. Informed the committee of the May meeting to prepare questions for the upcoming review of the charter and commissions.

Patton asked if this will be a public meeting.

Council Liaison/Mayor Bigstycyk Bigstycyk confirmed that it will not, but *Patton* is welcome to e-mail any suggestions over.

Cardona asked questions regarding the Climate Adaptation Plan.

Council Liaison/Mayor Bigstycyk Bigstycyk confirmed no new updates but advised Staff to check if there are any mailing lists created for citizen advisory.

STAFF COMMUNICATIONS:

3. **Development project updates** – *Staff Liaison Lin* provided new updates on the Quarry Reclamation Plan, for the hearing scheduled for the June 5th Planning Commission hearing.

Patton provided updates on Park Pacifica Stables, with the applicant moving forward with amending the retroactive grading permit.

Council Liaison/Mayor Bigstyc/Mayor Bigstyc elaborated the legal background between the City and the landowner.

Arnos provided details about the locked gates at the Pacifica Stables.

Council Liaison/Mayor Bigstyc provided responses in regards to his understanding with the public and correspondence with the individual about the subject.

Aaron Reif (Pacifica) provided public comments about the trail conditions around the area.

Sue Gardner (GGNPC) commented on the importance of the committee acting as a liaison between the community and the national park, along with other local surrounding parkland. Stated OSPAC is a very important channel.

Goodmiller comments on how the presentation was well prepared with imagery and details. Provided suggestions to amplify the amount of hours that were put in this season.

Cardona provides additional language that would be beneficial to include in the presentation.

Aaron Reif (Pacifica) provided public comment to identify the first work day of this season, along with other timestamp for the presentation photos.

McDermod suggested to have the CalTopo map be included in the presentation.
