RESOLUTION NO. 63-2018

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 6, 2018

WHEREAS, a consolidated general municipal election was held and conducted in the City of Pacifica on the 6th day of November, 2018, as required by law; and

WHEREAS, the election of candidates to the following seats: City Council (three seats) for a full term of four years were placed on the November 6, 2018 Official Ballot; and

WHEREAS, notice of the election was given in time, form and manner provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns were made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, California Elections Code provides that for a consolidated election, the City Clerk, upon receipt of the results of the election from the elections official conducting the election, shall certify the results to the governing body; and

WHEREAS, on December 6, 2018 the City Clerk received the final certification in connection with the subject election from the San Mateo County Chief Elections Officer; and

WHEREAS, a copy of the final Certification is attached hereto as "Exhibit "A" and incorporated herein by reference; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PACIFICA DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of votes cast in the City for each candidate is set forth in Exhibit A by this reference.

SECTION 2. That the names of the persons voted for at said municipal election for the office of City Councilmember the number of votes given in the City to each candidate, as shown on "Exhibit A" attached, are as follows:

Sue Beckmeyer (full 4 year term)	8,099 votes
Mary K. Bier (full 4 year term)	7,527 votes
Mike O'Neill (full 4 year term)	7,469 votes
Vickie Flores (full 4 year term)	6,630 votes
John Keener (full 4 year term)	6,543 votes
Adonica Shaw Porter (full 4 year term)	5,465 votes
Bridget Duffy (full 4 year term)	2,436 votes

SECTION 3. The City Council does declare and determine that Sue Beckmeyer, Mary K. Bier and Mike O'Neill received the highest number of votes cast for the office for which each was a candidate and are thereby declared elected to said respective City Council offices for

terms ending November 2022 (full four-year term).

SECTION 4. The City Clerk shall enter on the records of the City Council of the City of Pacifica, a statement of the result of the election showing: (1) The whole number of votes cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The total number of votes given to each person.

SECTION 5. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that to each person elected the Oath of Office shall be administered as prescribed in the Constitution of the State of California; and that each and all of the persons so elected shall be inducted into the respective office to which they have been elected.

SECTION 6. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
