



## CITY OF PACIFICA

### **WARRANTS FOR DESIGNATION OF PARKING FOR DISABLED PERSONS IN A RESIDENTIAL AREA**

A parking space in a residential area may be designated with blue paint on the curb and/or a distinctive sign for the exclusive use of vehicles which display a distinguishing license plate or placard issued pursuant to Section 22611.5 or Section 9105 of the Vehicle Code when all of the following conditions exist:

1. The owner of the property whose frontage includes the parking space proposed to be so designated makes a written request for such designation, and
2. The owner of the property shall submit with his/her written request proof of ownership of a vehicle with a distinguishing license plate or a placard issued pursuant to the above sections of the Vehicle Code, and
3. Intense on-street parking demand exists in the area, and
4. The property lacks a garage or has a narrow single car garage (less than 14 feet in width measured wall to wall), and
5. The driveway is too short or narrow (can not be lengthened to 19 feet or widened to 14 feet) or the driveway is steep (slope exceeds 8.33%), and
6. No other suitable off-street parking space is available in the opinion of the City Engineer, and
7. All reasonable alternatives to providing an exclusive parking space have been investigated, tried and failed or there is no alternative.

Any designation of a parking space made pursuant to these warrants shall be for a period of one year only. At the end of that time the owner shall submit evidence that he or she is still qualified under number 2 above and that all other conditions remain the same. If the City Engineer is satisfied with such evidence, the designation may remain in effect for another year and so on until the conditions change or the owner requests removal.

If at any time the designated parking space becomes unnecessary or hazardous in the opinion of the City Engineer, it may be removed without notice and without incurring any responsibility on the part of the City of Pacifica.

No parking space may be designated with blue paint on the curb and/or a distinctive sign if; the length of the curb is less than 20 feet in length, and/or the street is less than 29 feet in width, and/or the existing pavement exceeds 8.33% in slope.

A parking space in a residential area designated with blue paint on the curb and/or a distinctive sign is not for the exclusive use of the applicant. Any vehicle which displays a distinguishing license plate or placard issued pursuant to Section 22611.5 or Section 9105 of the Vehicle Code can also park in this space.
