

Project Overview

The Beach Boulevard Infrastructure Resiliency Project will protect public infrastructure, recreational activities, homes, businesses, and the community at large from further impacts due to continued coastal erosion. It aims to replace the current seawall and outdated infrastructure while building climate resilience into one of the most vulnerable segments of the the City of Pacifica's shoreline.

The Project is an infrastructure protection and improvement project that is critical to the public health and safety of the residents and visitors in and around the historic West Sharp Park neighborhood.

The Project entails assessing the entire span of the current infrastructure and seawall which includes four different structures: the north wall, the pier sheet pile wall, the south wall, and south gap.

Preferred Concept Design

The preferred concept design for the Project is a hybrid shoreline protection system consisting of a seawall, rock scour apron and natural shoreline infrastructure.



- Protection of West Sharp Park from wave overtopping, coastal erosion, and sea level rise.
- Secured public infrastructure of roads and underlying sewer mains, storm drains, and gas and electrical conduit.
- Improved public access to the beach.
- Protection of recreational use of the Promenade for walkers, joggers, cyclists, and others.







Phased Approach & Timeline

The City of Pacifica concluded Phase 1 of the Project in June 2021 with City Council's adoption of a preferred concept to replace the existing seawall. The Project is currently in Phase 2A, Preliminary Design, which aims to advance the shoreline protection concept as well as land-side features include landscaping, hardscaping, beach access, and community amenities.
