

RESOLUTION NO. 61-2023

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA APPROVING (UPON APPROVAL OF THE FY 2023-24 BUDGET) THE CONSTRUCTION CONTRACT WITH PACIFIC POLYMERS INC. IN AN AMOUNT NOT TO EXCEED \$464,196.60; AUTHORIZE A BUDGET AUTHORITY IN THE AMOUNT OF \$535,000, WHICH INCLUDES CONTINGENCIES IN AN AMOUNT NOT TO EXCEED FIFTEEN PERCENT (15%) OF THE CONSTRUCTION CONTRACT AMOUNTS; AUTHORIZE STAFF TO EXECUTE FUTURE CHANGE ORDERS NOT TO EXCEED THE CONTINGENCY AMOUNT; AND AUTHORIZE THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATED TO THE COMMUNITY CENTER ROOF COATING PROJECT

**WHEREAS**, consistent with the City of Pacifica's Bidding Procedures for Public Projects (Municipal Code Title 3 Chapter 15) the City of Pacifica advertised the Request for Bids for Community Center Roof Coating Project on April 12, 2023 and April 19, 2023; and

**WHEREAS**, the low bidder was Pacific Polymers Inc, dba American Foam Experts; and

**WHEREAS**, the work is needed to repair the Community Center Roof and allow for installation of solar panels by Peninsula Clean Energy (PCE).

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Pacifica authorizes the City Manager to execute all documents related to the Community Center Roof Coating Project.
