

RESOLUTION NO. 29-2017

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA DESIGNATING THE PACIFICA PARKS, BEACHES, AND RECREATION COMMISSION AS THE CITY BICYCLE AND PEDESTRIAN ADVISORY COMMITTEE (BPAC)

WHEREAS, MTC updated its policies and procedures for TDA, Article 3, Pedestrian and Bicycle funding on June 26, 2013. The new policies and procedures include a requirement that each county and city have a Bicycle Advisory Committee (BAC) to review each project and program that is proposed to be funded by TDA, Article 3 funds; and

WHEREAS, the City Parks, Beaches, and Recreation Commission is formed by seven members who are appointed directly by each City Council member, and

WHEREAS, the Parks, Beaches, and Recreation Commission is composed by local residents who are pedestrians and bicyclist ensuring an intermodal perspective towards bicycle and pedestrian planning and project prioritization; and

WHEREAS, through the collective knowledge of the Commission members, the Parks, Beaches, and Recreation Commission has comprehensive awareness of the needs of cyclists and pedestrians of the City; and

WHEREAS, Pacifica Municipal Code section 2-2.303 provides for the powers and duties of the Parks, Beaches and Recreation Commission; and

WHEREAS, these powers and duties include assisting in the preparation and adoption of, and reviewing long-range planning for City recreation, making recommendations concerning the beautification development and improvement of parks, beaches, and recreation services, and coordinating the recreation and park services with the programs of other governmental agencies; and

WHEREAS, the Parks, Beaches, and Recreation Commission meets all the requirements established by the State and MTC to review and prioritize bicycle, pedestrian, and other transportation projects and programs;

NOW, THEREFORE, BE IT RESOLVED, that the Pacifica City Council hereby designate the Parks, Beaches, and Recreation Commission as the City Bicycle and Pedestrian Advisory Committee (BPAC).

BE IT FURTHER RESOLVED, that the City of Pacifica City Council hereby designates the Parks, Beaches and Recreation Commission as its review body for TDA Article 3 purposes.


