

RESOLUTION NO. 104-2023

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA
APPROVING AMENDMENT NO. 4 TO THE INTER-AGENCY AGREEMENT WITH THE
SAN MATEO RESOURCE CONSERVATION DISTRICT AND APPROVE AGREEMENT
WITH SAN MATEO COUNTY FOR THE PACIFICA STATE BEACH BACTERIA
TMDL SPECIAL STUDY SERVICES; AND AUTHORIZE THE CITY MANAGER TO
EXECUTE ALL DOCUMENTS**

WHEREAS, the Basin Plan Amendment established the Total Maximum Daily Load (TMDL) for bacteria in San Pedro Creek and at Pacifica State Beach and was adopted by the San Francisco Bay Regional Water Quality Control Board (Regional Water Board) on November 14, 2012; and

WHEREAS, the TMDL required the development of a Bacteria Water Quality Best Management Practices (BMP) Implementation and Monitoring Plan for the San Pedro Creek watershed to reduce discharges of bacteria to the storm drain systems to attain wasteload allocations; and

WHEREAS, on November 28, 2016, the City and County approved the Inter-Agency Agreement with the San Mateo Resource Conservation District (RCD) for the San Pedro Creek and Pacifica State Beach Bacteria TMDL Monitoring Services and approved the Agreement with San Mateo County for Reimbursement of the Costs; and

WHEREAS, on December 28, 2016, City approved Amendment No. 1, on August 11, 2020, City Manager approved Amendment No. 2, and on August 9, 2021, City Council approved Amendment No. 3; and

WHEREAS, the San Francisco Bay Regional Water Quality Control Board is requiring a Special Study Plan for conducting bacteria water quality monitoring along the Pacifica State Beach;

NOW, THEREFORE, BE IT RESOLVED that the Governing Board of the City of Pacifica authorizes the City Manager to execute Amendment #4 with RCD and Agreement with San Mateo County for the Governing Board.
