**CALL TO ORDER:**

**Chair Abbott:** called the meeting to order at 7:02 pm.

**I PLEDGE OF ALLEGIANCE:**

**Staff Present:** Director Bob Palacio, Recreation Supervisor Anthony Schriver, Recreation Coordinator Lexi Macario and Recreation Specialist Rebecca Collier

**III APPROVAL OF MINUTES:**

**Chair Abbott** called for a motion to approve the minutes June 28, 2023. **Motion was made by Commissioner Phillips, seconded by Commissioner Benton-Shoemaker, motion carried 5-0.**

**IV ADOPTION OF THE AGENDA:**

**Chair Abbott** called for vote to approve the agenda of the 08/23/2023 meeting. **Motion carried 5-0.**

**V INTRODUCTION OF NEW COMMISSIONER**

Introduction of Commissioner Mark Torres: He has lived in Pacifica for the past 12 years with his family. He is currently working for San Francisco Utilities Commission. He is excited to join the Parks, Beaches, and Recreation (PB&R) Commission. He intends to focus on improving and development of more recreation sports fields and facilities in the City of Pacifica.

**VI SPECIAL PRESENTAION:**

Recreation Coordinator Lexi Macario and Recreation Supervisor Anthony Schriver introduced themselves to the Commission. Coordinator Macario gave an overview of the Recreation Programs and Facilities. She recapped and elaborated on the following topics:

- Youth and Teen
- Summer Adventure Camp
- Youth Advisory Board (YAB)
- Special Events – Spring Egg Hunt, Jr. Olympics, and 4<sup>th</sup> of July

- Contracted Classes
- Community Center Rentals

Recreation Supervisor Schriver gave an overview of the Aquatics programs. He recapped and elaborated on the following topics:

- Water Aerobics
- Swimming Lessons
- Wet and Wild Camp
- Surf Survival Apnea Course
- Lifesaving Buoy Station
- 2023 Rocket Run

Summary of questions from Commissioners:

- 1) Is focus on recurring programs/events growth or refining?
- 2) How close are participation and attendance for programs/events compared to pre-pandemic levels?
- 3) Why Jr Olympic timing system that was donated by the Lions Club was not being utilized?

Staff Response:

- 1) Focus is on both growth and refining programs/events. Areas of focus in the future will be utilizing the community center for contract programs once the new Civic Center is complete and staff have moved. Programs/Event staffing levels are important in any event or program quality.
- 2) Across all programs and events participation numbers are steadily increasing to pre-pandemic levels. Programs had sold out quickly and seeing returning participants, which indicates quality of programs. Focus moving forward will continue with producing quality programs/ events and then continue to expand with other new programs/events.
- 3) Jr Olympic timing equipment and software became obsolete and was more expensive to update the software and equipment then hiring a timing company with the most up to date equipment.

**Chair Abbott** called for a motion to approve the Items for Consent. **Motion was made by Commissioner Benton-Shoemaker, seconded by Commissioner Phillips, motion carried 5-0**

**IX ITEMS FOR CONSIDERATION:**

- A. Priority Parks-** Director Palacio gave a status update on the sixty-five percent construction documents of the four priority parks (Brighton, Marvilla, Imperial and Skyridge) cost. All four parks construction plan estimates came in over the original budget of \$1.2 million for all four parks. The project extensive scope of work includes, new pathways, vegetation planting, irrigation, and playground equipment installation. Cost also included construction, contingency and design

costs. City staff did a value engineering cost review with NCE Consulting. After review staff asked, NCE for adjustments and updated cost estimate to meet the original budget of \$1.2 million. NCE made reduction in some materials such as pavement and surfacing along with some reconfiguration in some of the park's update. Staff will update PB&R Commission with new cost estimates for each park once new information has been received. In the future, staff will develop uniform signage to create cohesiveness and brand recognition for all City of Pacifica Parks.

**Summary of PB&R Commission suggests on design elements:**

- 1) Larger concrete seating be replaced with more all age friendly
- 2) Multi stream trash bins instead of single bins
- 3) Review of dog waste station's locations
- 4) Bike racks/parking in all parks
- 5) Review of reducing element(s) at Imperial Park, if a need to reduce cost to stay within budget of the project
- 6) Improved signage at all parks
- 7) Additional picnic seating at Skyridge park.

**X REPORTS, ANNOUNCEMENTS, AND CORRESPONDENCE FROM COMMISSIONERS:**

Commissioners gave updates on their liaison assignments and community involvement.

**XI REPORTS FROM STAFF:**

Director Palacio: Gave updates on the following:

- **Surf Camp/School Policy:** Staff will meet with surf camp providers on August 30, 2023. Surf camp providers will have the opportunity to give a review of their summer and address any challenges and celebrate success.
- **Play Structure Improvement:** Consist of replacing the existing play structures with new updated equipment and are less comprehensive than the Priority Parks Projects.
  - Fairway Park: Construction began Aug 23, 2023
  - Saltaire Park: Waiting on construction date
  - Oddstad Park: More information in the future
- **Teens:** Director Palacio and Recreation Supervisor Schriver took a group of twenty (20) youth skateboarders on two trips and visited five skateparks around the Bay Area and one waterpark in August.
- **Bike Park:** Pacifica Bike Park Committee, Commissioner Phillips, and Staff met with American Ramp Company (ARC) to solicit another quote for design concept and outreach services. Staff submitted a Recreational Trails Grant Application with the California State Department of Parks and Recreation in the amount of \$1.55M for design and construction of a Bike Park, the grant requires a 12% match from the city.
- **Marketing and Branding:** Working with Staff and Commissioner Rodriguez to implement a new marketing plan and logo.
- **Facilities:** Staff applied for \$3.5 million grant for upgrades to Pacifica Community Center with California Strategic Growth Council. The building is a gathering space for the public during disasters, the needs updated HVAC, electrical, flooring and more. At Fairway Park all three backstops will be replaced in the next few months.

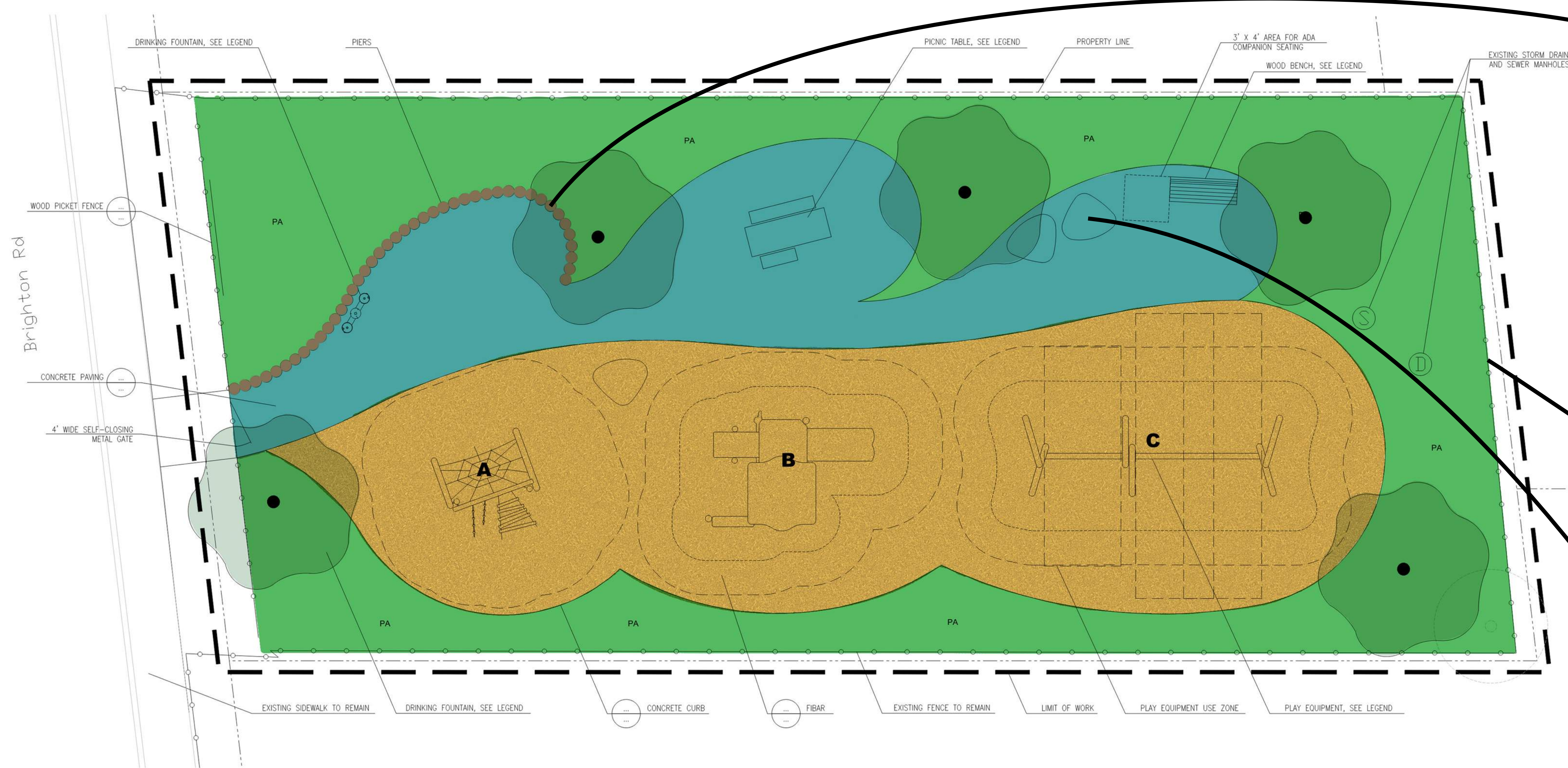

MATERIAL PLAN

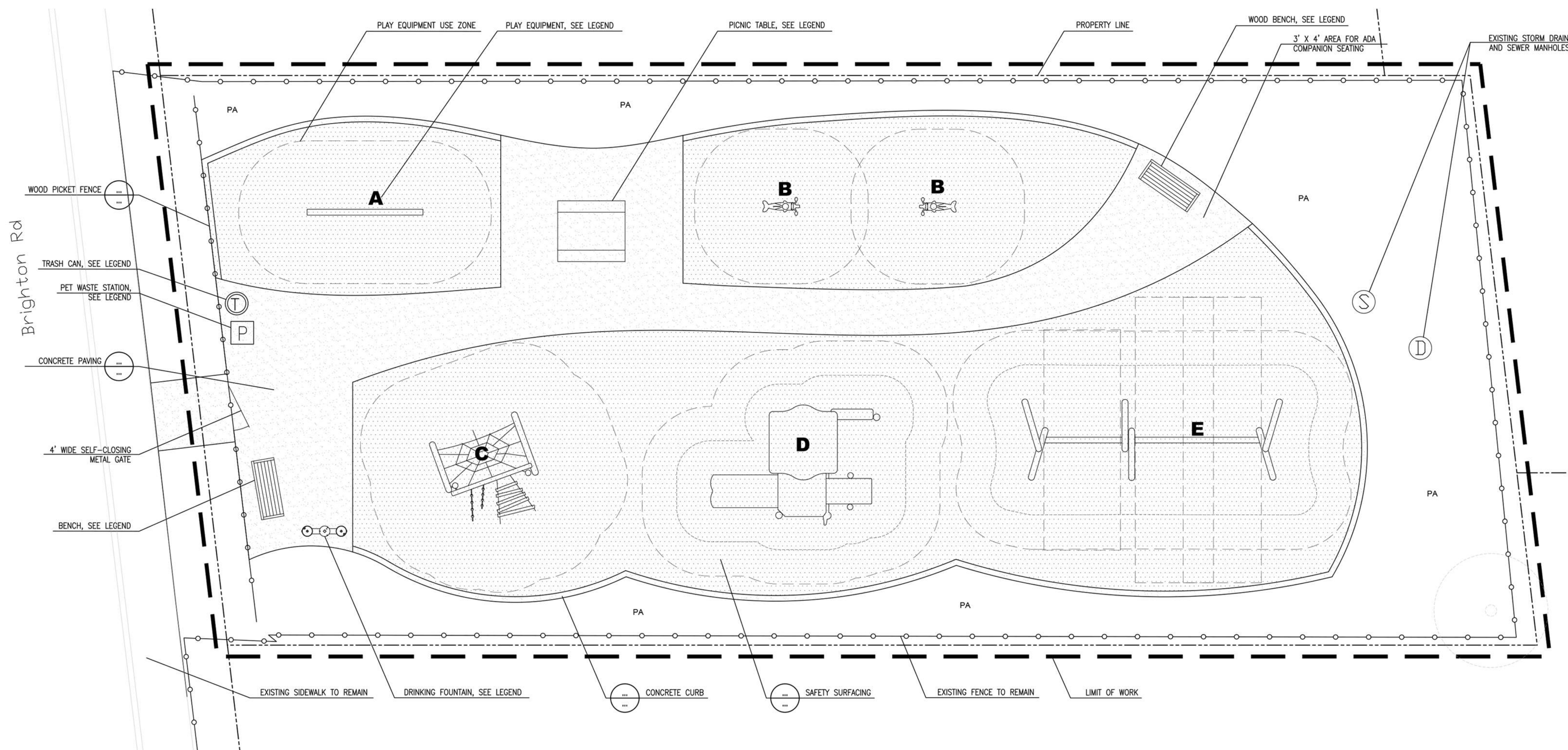

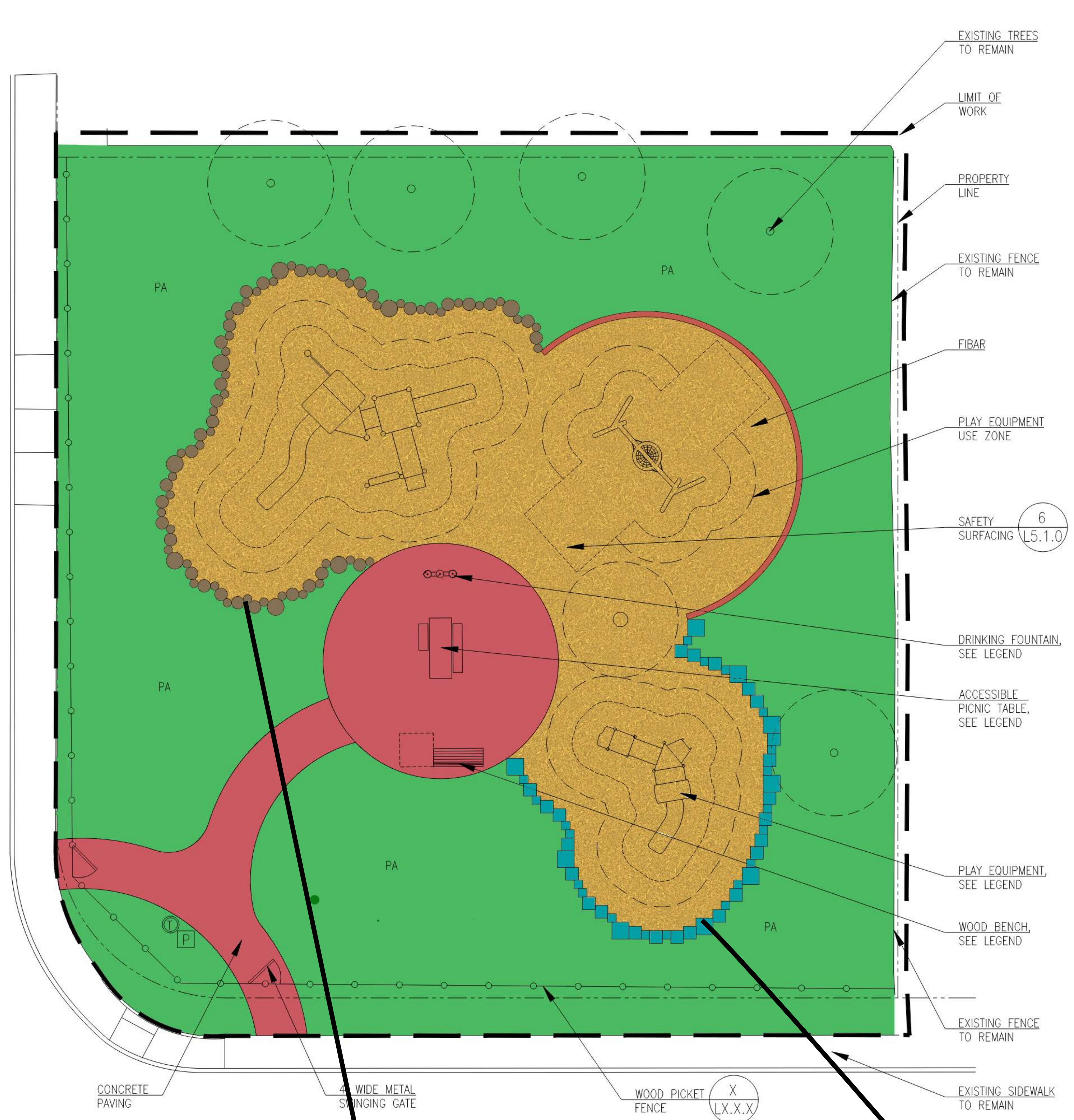

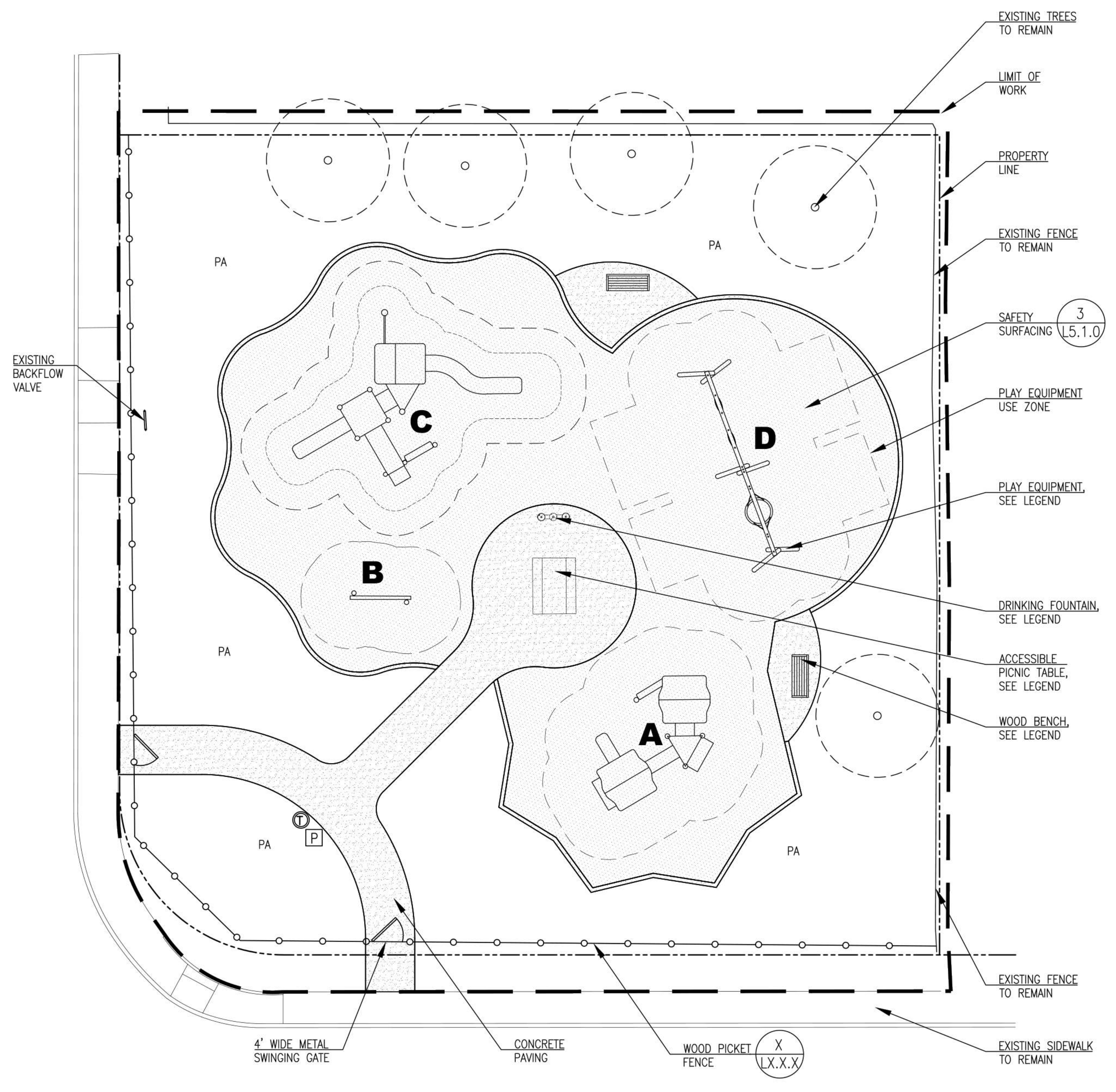

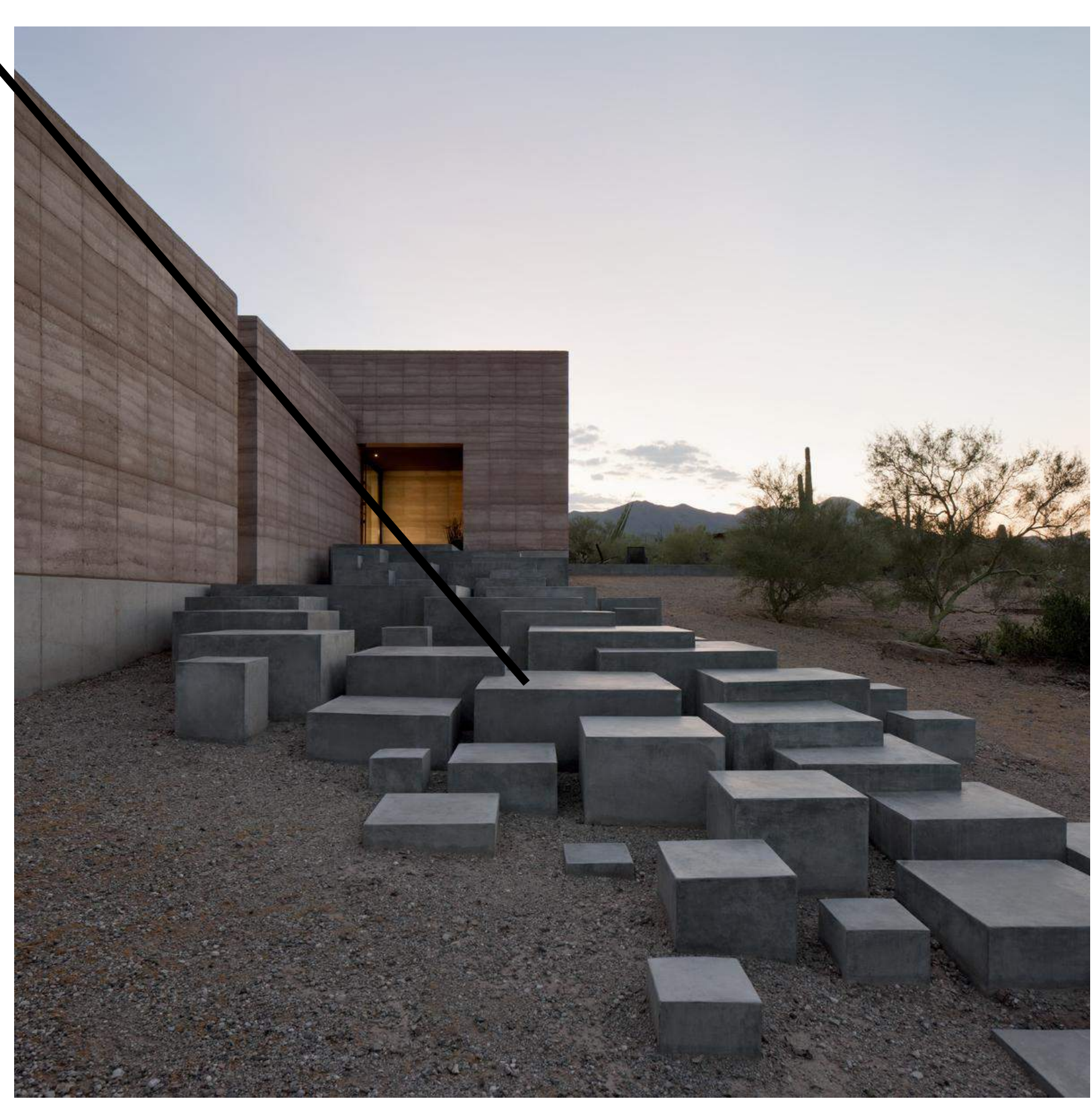

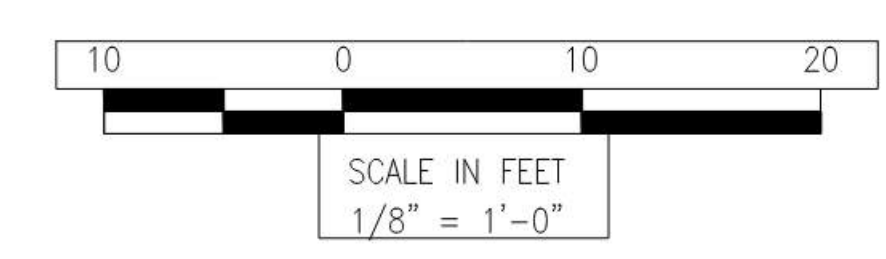

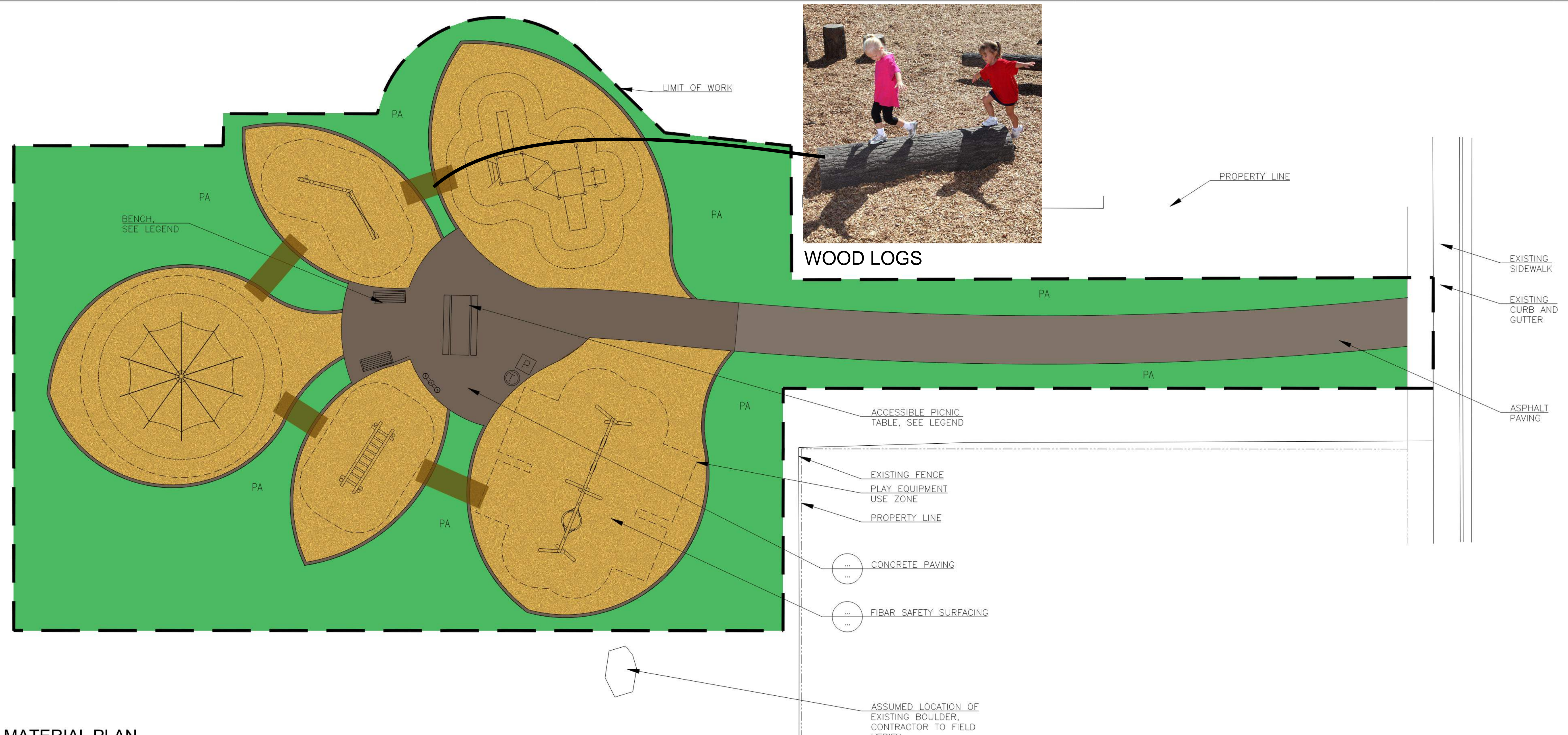
ROUND CONCRETE BLOCKS

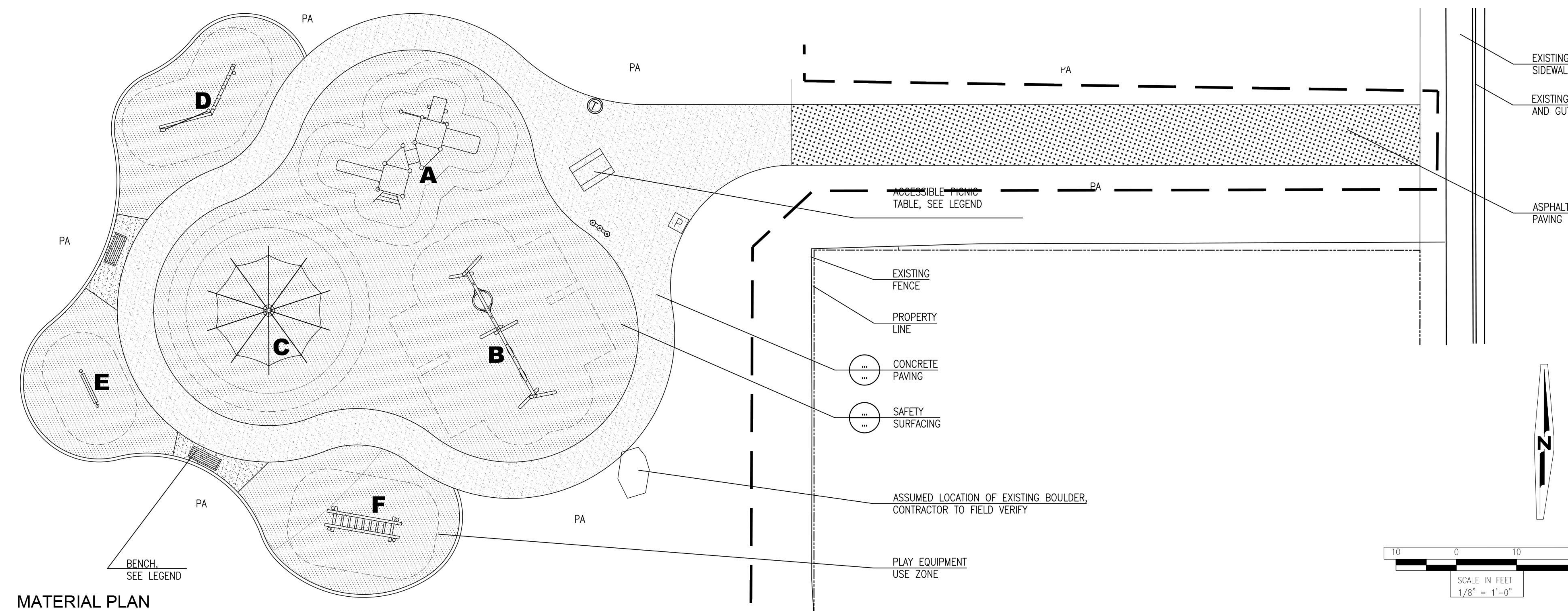

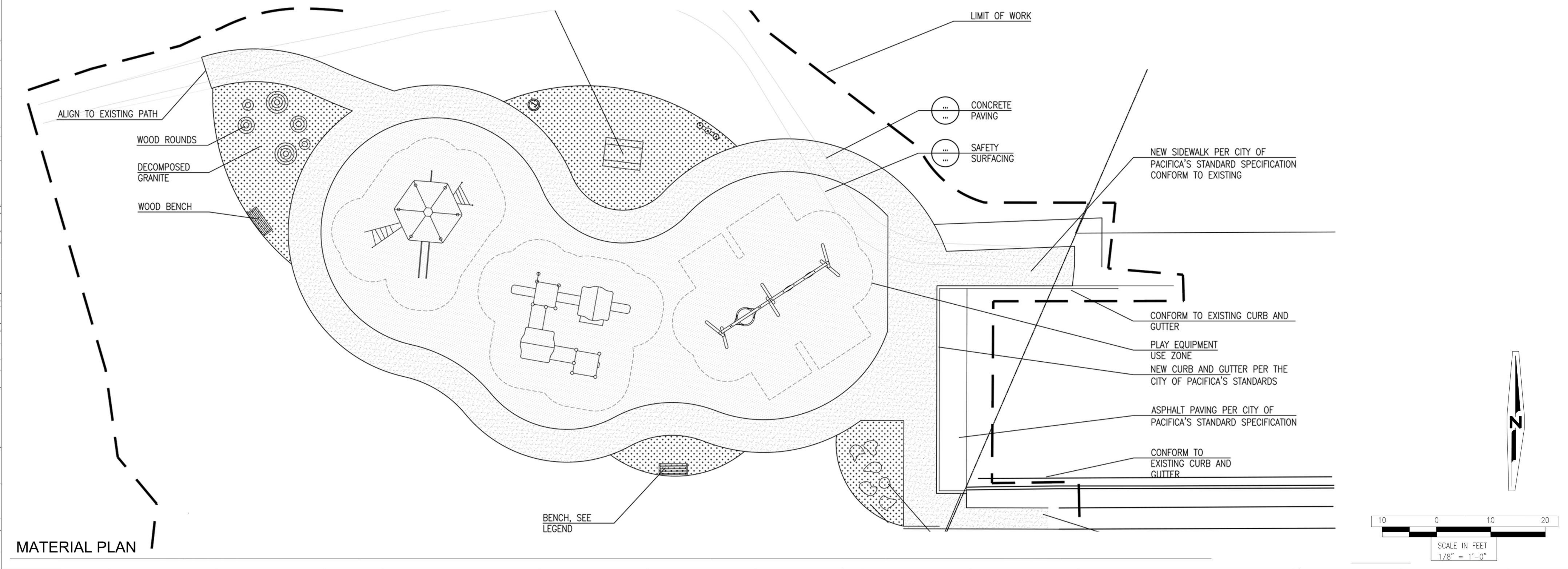
