

RESOLUTION NO. 125-2023

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA  
APPROVING THE AMENDED PURCHASE AGREEMENT BETWEEN THE CITY OF  
PACIFICA AND VAC-CON, INC. INCREASING THE CONTRACT AMOUNT BY \$42,538.48  
FOR THE PURCHASE OF A VAC-CON G2 VT310LHAE/1300 TRUCK  
FOR THE WASTEWATER DIVISION**

**WHEREAS**, the City Council during their regular meeting on November 28, 2022, adopted Resolution No. 82-2022 which approved a budget of \$1,979,660 and to purchase vehicles that are considered critical for replacement for Fiscal Year 2022-23; and

**WHEREAS**, the City Council during their regular meeting on January 9, 2023, adopted Resolution No. 07-2023 approving Vehicle Replacement Phase I for Fiscal Year 2022-23 totaling \$1,488,997.93 which included the purchase of the Vac-Con G2 VT310LHAE/1300 Truck (Vac-Con) in the amount of \$618,859.61 for the Wastewater Division due to age and maintenance issues; and

**WHEREAS**, the City used the Sourcewell CA State Contract as the procurement method for the Vac-Con that allows for negotiated prices that are lower than retail prices; and

**WHEREAS**, staff required vehicle add-ons for utility location, extra long hose reel and upgraded traffic lights that cost an additional \$42,538.48 more than the original approved budget of \$618,859.61 putting the total cost at \$661,398.09;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pacifica to: Approve the Amended Purchase Agreement between the City of Pacifica and Vac-Con, Inc. increasing the contract amount by \$42,538.48 for the purchase of one Vac-Con G2 VT310LHAE/1300 Truck for the Wastewater Division; transfer of \$42,538.48 from Wastewater Fund 18 to the Vehicle Replacement Fund 72; and authorize the City Manager to execute all documents related to the purchase.

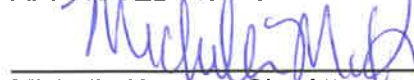
