

**RESOLUTION NO. 61-2017**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA DECLARING THE RESULTS OF THE CONSOLIDATED MUNICIPAL, SCHOOL AND SPECIAL DISTRICT ELECTION HELD ON NOVEMBER 7, 2017**

---

**WHEREAS, a consolidated municipal, school and special district election was held and conducted in the City of Pacifica on the 7th day of November, 2017 as required by law; and**

**WHEREAS, California Elections Code provides that for a consolidated election, the City Clerk, upon receipt of the results of the election from the elections official conducting the election, shall certify the results to the governing body; and**

**WHEREAS, on December 5, 2017 the City Clerk received the final certification in connection with the subject election from the San Mateo County Chief Elections Officer; and**

**WHEREAS, a copy of the final Certification will be attached hereto as Exhibit "A" and incorporated herein by reference; and**

**WHEREAS, the governing body must, no later than the third Friday following presentation of the 30-day canvass of returns, adopt a resolution which: recites the fact of the election; the whole number of votes cast in the City; the names of the persons voted for; what office each person was voted for; the number of votes given at each precinct to each person; and the number of votes given in the City to each person and the City Council must also declare elected the persons for whom the highest number of votes were cast for each office.**

**NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Pacifica hereby resolves as follows:**

**1. Measure C voted on at said Consolidated Municipal, School and Special District election read as follows:**

**Shall the Ordinance entitled Pacifica Community Preservation, Rent Stabilization, and Renters' Rights Act which protects certain tenants of multi-family housing from excessive rent increases and no-fault evictions and ensures that Landlords receive a fair and reasonable rate of return on their investment, be adopted?**

**That the record of votes cast a said Consolidated Municipal, School and Special District election for and against Measure C, as shown on Exhibit A attached hereto, was: 4,354 YES; and 6,640 NO; and that a majority of all votes cast on Measure C were against said measure and said measure failed.**

**2. Measure G voted on at said Consolidated Municipal, School and Special District election read as follows:**

**Shall an Ordinance establishing a Marijuana Operations Tax at the rate of 6% of a Marijuana Operation's gross receipts, which may be decreased or increased after two**

years to a maximum of 10% by the City Council, to help fund municipal services, including police and fire protection services, emergency medical services, park, recreation, and street maintenance services, with no sunset date and estimated to generate \$360,000 annually in tax revenue, be adopted?


That the record of votes cast at said Consolidated Municipal, School and Special District election for and against Measure G, as shown on Exhibit A attached hereto, was: 8,588 YES; 2,316 NO; and that a majority of all votes cast on Measure G were in favor of said measure and said measure passed.
