

RESOLUTION NO. 142-2023

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA APPROVING THE CONSTRUCTION CONTRACT WITH DRYCO CONSTRUCTION, INC. IN AN AMOUNT NOT TO EXCEED \$99,994.00; AUTHORIZE A BUDGET AUTHORITY IN THE AMOUNT OF \$114,993.10, WHICH INCLUDES CONTINGENCIES IN AN AMOUNT NOT TO EXCEED FIFTEEN PERCENT (15%) OF THE CONSTRUCTION CONTRACT AMOUNTS; AUTHORIZE STAFF TO EXECUTE FUTURE CHANGE ORDERS NOT TO EXCEED THE CONTINGENCY AMOUNT AND AUTHORIZE THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATED TO THE FRONTIERLAND PARK ADA IMPROVEMENT PROJECT**

**WHEREAS**, the City Council approved the 2023-28 Capital Improvement Program on June 26th, 2023. The CIP proposed capital projects includes the Frontierland Park ADA Improvement Project; and

**WHEREAS**, the Frontierland Park ADA Improvement Project will grading, excavation and hauling, and the construction of an ADA compliant asphalt trail, with ADA handrails and redwood header in Frontierland Park; and

**WHEREAS**, consistent with the City of Pacifica's Bidding Procedures for Public Projects (Municipal Code Title 3 Chapter 15) the City of Pacifica advertised the Request for Bids for Frontierland Park ADA Project on October 4, 2023 and October 11, 2023; and

**WHEREAS**, the low bidder was DRYCO Construction, Inc.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pacifica to Adopt the Resolution Approving the Construction Services Agreement between the City of Pacifica and DRYCO Construction, Inc. for the Frontierland Park ADA Improvement Project, in an Amount Not to Exceed \$99,994 with a 15% Contingency in the amount of \$14,999.10 for a Total of \$114,993.10; and authorize the City Manager to execute all documents related to the project.
