Chair Abbott: called the meeting to order at 7:02 pm.

Chair Abbott called for a motion to approve the minutes September 27, 2023. Motion was made by Commissioner Nicolari, seconded by Commissioner Rodriguez, motion carried 7-0.

Commissioner Benton-Shoemaker: Appreciated administrative update information about the new Aquatics Coordinator position.

Chair Abbott: requested for future staff reports to include comparison data for programs and events.

Chair Abbott called for a motion to approve Items for Consent. Motion was made by Commissioner Torres, seconded by Commissioner Phillips, motion carried 7-0.

VII ITEMS FOR CONSIDERATION:

A. Liaison Assignments

Director Palacio: Asked Commissioners to confirm or change their current liaison assignments and add any new assignments if needed.

Commissioner Benton-Shoemaker: Stated, since the Library Advisory Committee had not met for serval years, if Chair Abbott would take over the liaison since she is a member of the task force?

Chair Abbott: Clarified she is a member of the task force as a community member not as an official liaison for Parks, Beaches, and Recreation (PB&R) Commission. She would be more than willing to report back as a community member.

B. Special Events and Public Appearances

Director Palacio: He spoke with Economic Development (ED) Manager Tara Schiff about future City special events. His belief special events should have a purpose and of course be fun/entertaining. Events should act as a hook for a greater purpose and wanted input from PB&R Commission for future special events. He would like discussion in length at a future study session setting. Public Appearances, his hope would be to have at least one PB&R Commissioner at all future special events. He also would like other community organizations and local business to be more visible and aware of events in the City.

Chair Abbott: Commented, great idea to have PB&R Commissioner(s) in attendance at PB&R special events. She appreciated Director Palacio speaking with ED Manager Schiff. The Economic Development Committee frequently speaks about events but not necessary with a purpose and lack of experience organizing special events. Partnership with ED, PB&R department expertise on special events would help formalize events for the City.

X REPORTS, ANNOUNCEMENTS, AND CORRESPONDENCE FROM COMMISSIONERS:

Commissioners gave updates on their liaison assignments and community involvement.

XI REPORTS FROM STAFF:

Director Palacio: Gave updates on the following:

- **Lifesaving Buoy Rings:** City Manager approved Staff for emergency installation of two Lifesaving Buoys at the southern end of Sharp Park Beach. Staff received tentative approval from California Coastal Commission at Linda Mar Beach. City will be posting signage for pending permit for installation. Once final permit has been received staff will be ready to install at Linda Mar Beach.
- Priority Parks: Thanked the PB&R Commissioners for their input on the 65% plans and should have received 3D renderings of all four parks. Once staff receives the 95% plans, staff will bring to the PB&R Commission for their review.
- Play Structure and Backstop Installment: Fairway Park new play structures
 have been installed. Saltire Park play equipment replacement would be starting in
 mind- November. He received a comment from a community member regarding
 fibar usage and accessibility. Fibar does meet ADA standards but is not as easy
 rubberized surface. He hopes to find funds to pay for the extra cost to for the use
 of rubberized surface in one of the parks. Backstops replacements, accepting bids
 for the equipment and installation.
- **Bike Park:** Director Palacio and Commissioner Phillips met with State of California OGAL's at lower Frontierland Park to do a walk through at the site for the Recreational Trails Grant \$1.55 million grant that for the construction of the bike park. There was a request for more extensive information and updates on

- the materials submitted for the grant. Staff did a lot of hard work to provide and submit the requested information.
- Staff Report: Child Care Site Coordinator, Greta Hayes retired at the end of September and was recognized by City Council for 25 years of service to the City of Pacifica. Open recruitment for 18 years old or older Lifeguards to help with staffing at Brink Pool. New position Aquatics coordinator was approved by City Council and recruitment would go out by the first of November. The position will allow for more program offerings and staff supervision and development in the Aquatics division.
- Permanent Pickleball court's locations: Staff reviewing locations for
 pickleball courts, spoke with Chair Abbott about one location behind Sanchez
 Library, will speak with City of San Francisco about an area that was capped near
 the archery range and the other location at Fairmont Park were the basketball
 court are located.
- Arbor Day Proclamation: Presented at City Council meeting on October 23, 2023.
- **Special Events:** Fog Jog had over 100 runners participate up from last year's numbers and Fun Fest was successful with approximately 2,000 attendees excited with all the events offerings.
- **Study Session:** Date in December to review surf camps, 2024 Work Plan, special events, branding and marketing.

Commissioner Phillips: Asked if the basketball court at Fairmont Park are used frequently?

Director Palacio: Answered, yes and the basketball court would not be eliminated, area would be reconfigured to include 2 pickleball courts and one basketball court. **Commissioner Heywood:** Asked for confirmation on the location near the archery range and asked if it would be a day light only pickleball courts?

Director Palacio: Responded, community member wanted staff to review. If possible, would want Pickleball courts on both sides of the city.

All Commissioners: Agreed, December 13, 2023, as the study session date with a start time 6:00pm.

Chair Abbott: Asked Director Palacio if the Commissioners could have until November 22, 2023, to send him any 2024 Work Plan ideas?

Director Palacio: Agreed

XII ADJOURNMENT:

Chair Abbott: asked for motion to Adjourn. A motion was made by Commissioner Phillips, seconded by Commissioner Heywood. Motion carried 7-0.

Surf Camp/School Policy

Current: Registration of for Surf Camp/School permits occurred from December 1-15, 2023. We currently have 4 active permits, and are working with a 5th party. The process was straight forward and by all accounts successful.

Life Ring Buoy Station Program

Current: In addition to the 6 Life Buoy stations installed along the promenade, the City of Pacifica recently completed to additional emergency installations at the southern most end of the promenade at Sharp Park Beach. Anthony Shriver, Recreation/Aquatics Supervisor, has resubmitted an extensive and detailed new version of our application to install the remainder of the life buoy stations to CCC staff. The California Coastal Commission will here this item on February 9th via zoom meeting.

Priority Parks

Current: Thank you for your excellent feedback on the Four Priority Parks Projects! PB&R Commission input resulted in a much-improved design for these projects. There were some small changes needed for Brighton Park to create more fall zone that will allow for a slightly larger structure with additional playability.

Play Structure Improvements

Improvements primarily consist of replacing the existing play structures with new updated equipment and are less comprehensive than the Priority Parks Projects.

Staffing Updates

The following are our staffing updates:

- Meals on Wheels Coordinator Recruitment and Selection: Rebecca Collier
- Aquatics Coordinator: Interviews underway
- Recreation Specialist: James Mulvey left the department
- Recreation Specialist Recruitment: 60 applicants
- Lead Teacher: Recruitment underway

Recreation Coordinator of Aquatics (New Position Background)

The City of Pacifica has an active joint use agreement with the Jefferson Union High School District which allows the City to provide community aquatics programs. Jean E Brink Pool located on the Oceana High School campus is home to the City of Pacifica's 7 day per week robust aquatics program. Programming includes, but is not limited to, adult lap swim, recreational swim, water aerobics classes, swim lessons, water safety courses, swim team rentals, artistic swim organization rentals, swim camps, water polo, swim meets, and pool parties.

In early July 2022, as part of a Parks Beaches and Recreation department reorganization, the Recreation Coordinator position overseeing aquatics was eliminated. The funding for that position was used to fund a new Recreation Supervisor position that now oversees not only Aquatics, but also Recreation which includes contract instruction, beach and water safety initiatives, city-wide special events, summer camps, field users' agreements, and teen and youth programs. This restructuring has left a gap at the Jean E Brink facility which has been run entirely with part-time staff. As the recreational activities have now exceeded the pre-Covid level, this is no longer a sustainable staffing level for the programs performed at this facility.

It is important to note, that the community aquatics program at the Brink Pool facility is a 12 month a year, 7 day a week program. The greater majority of staff, which entirely consists of lifeguards, are under the age of 18. Past practice allowed for these non-adult staff to be left in the facility to guard the water and monitor the facility. To ensure the safety of all program participants and staff and prudent risk management practices the City's internal policy now requires a staff member, or contract instructor, to be at least 18 years old when in charge of the facility.

Addition of a new Recreation Coordinator in Aquatics would allow the department to regain prepandemic program and participation levels, and eventually grow and enhance programs. This new position will be able to develop, implement, and assess aquatic programs as this will be their focus. They would also be the lead staff point of contact on aquatics staff recruitment, development, interviews and hiring. They would enhance the overall safety of the facility and its users. The additional duties for this job class will include:

- Program facilitation, including but not limited to swim meets, swim lessons, and pool parties
- Initial inputting of staff hours into timesheet system
- Payment reconciliation for cash and checks
- Schedule staff shifts for on-deck aquatics staff
- Share duties for existing lifeguard on-going trainings
- Provide incoming lifeguards with required water safety/CPR/ AED certification training
- Assess equipment and infrastructure for needed maintenance and upkeep
- Assist in chemical testing as needed
- Check Brink Pool voicemail, answer phones, and respond to public as needed
- Perform lifeguard duties as needed
- Other duties as required including light custodial

This new position will be fully funded with new program revenues and salary savings from eliminating the unutilized part-time staff position (see Attachment A for additional detail).

New program revenues and salary savings on a fiscal year basis will amount to approximately \$115,800, which is sufficient to fund a full-time benefited Recreation Coordinator position on an

ongoing basis. The Recreation Coordinator is an existing classification within the City's classification plan, so no approval of this classification or meet and confer process with the labor representatives is required at this time. If approved, this additional position will be added to the Position Control and the FY 2023-24 Budget.

Bike Park Update

The Pacifica Bike Park Committee and Staff met with the State of California OGALS office on-site at the Lower Frontierland Property. Staff passed the initial stage of approval for our submittal of an RTP grant, and on Oct 17, 2023, Staff submitted our final version of the application which included:

- Project Application Form
- Site Plan
- Topographic Map and Survey
- Trail Log/Inventory and Reconnaissance Notes
- Design Standards
- Cost Estimate Form (\$1.8M)
- Project Location Map
- CEOA
- Property Ownership docs
- Required Regulatory Permits
- Grant Scope

Staff are still awaiting word from the State of California on whether we will be awarded this grant. PB&R are a finalist.

Trees

No Tree appeals have come in during this time. Arbor Day was a tremendous success with 20+ trees being planted at Fairway Park! Not only was this great for the environment, but the parks look is greatly improved. Thank you, Tree City Pacifica!!

Polar Palooza



Adult Lap Swim and Adult Water Aerobics

Swimmers from our community and surrounding cities continue to utilize our beautiful Jean E. Brink Pool. Pacifica Parks, Beaches and Recreation (PB&R) continue to offer swimmers and water aerobics participants 42 hours a week to come swim at our heated indoor pool. Our indoor pool facility makes for a warm swim or water aerobics workout 12 months out of the year as the water temperature is between 81-83 degrees. Water Aerobics Instructors Julie Zoph, Mary Germano, and Jayah Paley continue to have a dedicated following of participants on Mondays – Fridays, 11am-12pm with between 140-160 participants taking our one-hour aerobic workout each month. Staff are thankful and grateful for their dedication and hard-working efforts in keeping water aerobics participants moving and motivated.



The Jean E. Brink Pool offers the most lap swimming hours on the coast and peninsula.

Water Aerobics Schedule:

Monday - Friday 11am - 12pm

Recreation Swim

The Jean E. Brink Pool offers Family Recreation year around Monday, Friday evenings 7pm-9pm and Saturday afternoons 1pm-3pm. Between the month of October and December there were 840 swimmers who came to join family fun in the water. Family recreation swim gives families an opportunity to come dive or jump off our 1-meter low diving board, and high 3- meter diving board, splash around, practice their swimming skills, and have some pool time fun. Jean E. Brink Pool is one of the only pools in the bay area to offer diving boards and recreation swim year around.



Adult Water Polo

Adult FOG water polo is held Sundays 9am-11am. The program welcomes all skill levels. During the program water polo players conduct drills and scrimmage against one another. Each session there waws an average of 20 players come out totaling 302 attendees for the months of October, November, and December. Youth water polo will be coming back on Tuesdays and Thursdays evenings 7pm-8:30pm starting later in January 2024.



Oceana Pool Party Program and Swim Meets: October, November, and December

The Jean E. Brink Pool offers pool party rentals and swim meet rentals throughout the year. Our indoor facility is very popular and affordable in hosting team celebrations, birthday parties, and big swim meets. Guest can reserve the whole pool to themselves on Saturdays 3pm-6pm, and Sundays 1pm-3pm. Swim meets are held on Saturdays and Sundays, 6am-7pm with upwards of 400 athletes swimming each day.

Pool Party Program: \$180 per hour (up to 50 people, 2 hr. minimum)

Outside swim team meets: \$180 per hour.

Pacifica Sea Lions Swim Meet: \$125 per hour.

Fall Swimming Lessons

Fall swimming lessons were held Tuesday and Thursday evenings for four weeks, with each class being 30 minutes. There was a total of three sessions that took place, September 5th – September 28th, October 3rd – October 26th, and November 7th – December 7th along with Saturday lessons that happened once a week for eight weeks for 30 minutes each class that occurred October 7th – December 9th.

A total of 341 participants completed swim lesson this past fall with ages ranging from six months to adults. These lessons are invaluable to our community as instructors and lifeguards teach a lifelong skill. Instructors and Lifeguards have been doing an excellent job every week by providing participants

swimming skills that could one day save their life. It is so important to learn how to swim, especially living alongside the coast. Kudos to staff as they have such a big impact on our swimming program and educating participants how to swim and be safe around bodies of water.







J-Teen After School



Vallemar's J-Teen After School program is officially halfway done for the year! In October, staff added one more child off the waitlist, making the full roster to 27 children. Recreation staff Zackary Conci, Philomena De Barra, and Dylan Alexander-Hydie are there every day continuing to help the teens with homework and engage with them through games and activities. I have attached some photos of the teens celebrating Halloween.



Summer Adventure Camp

Adventure Camp will start the week of June 10, 2024, and it will be another eight weeklong summer camp. Staff plan on opening registration for summer camp in late January or early February. Staff plans to increase the numbers of children each week to 80-90 kids per week, increasing the number of campers by 10-20 each week more than summer of 2023. Field Trips planned 2024 camp will increased to 7 field trips instead of 4, and plans to contiune going to the pool every other week as well. Staff are currently planning to bring back to Adventure Camp the L.I.T.E program, (Leaders in training education), which is a program for 13–15-year-olds to get volunteer experience by helping facilitate activities at Adventure Camp.


Youth Advisory Board

The Youth Advisory Board (YAB) was extremely busy these past few months! Starting off strong with the first dance of the 23-24 school year on October 6th, at the Pacifica Community Center. The YAB did an amazing job of helping by planning the event by picking the neon dance theme, creating the fliers for the dance, picking out decorations to decorate the dance floor with, reaching out to schools PTOs, and by running the snack shack. YAB also had a booth at the Rockaway Tree Lighting Festival on December 3rd, where they hosted a create-your-own ornament booth. They got clear ornaments and colored sand to fill the ornaments with. This booth was free to everyone and had a busy crowd surrounding the table all night. At the Rockaway Tree Lighting Festival, YAB also held a toy drive. By the end of the night, YAB had a full box of toys that were donated to Half Moon Bay Coastside Clinic's Pediatric Patients. YAB also

executed the second dance in December, calling it the Blizzard Bash. The Blizzard Bash was on December 8th, and YAB did another great job decorating, planning, and assisting with the dance. In December, we added one new member to YAB, Hudson Dunhill, bringing YAB to 13 active members.

J-Teen Dances

In the 23-24 school year, staff had put on two J-teen dances so far. The first J-Teen dance was on October 6th, from 7-9pm at the Pacifica Community Center. This dance was Neon themed, and as soon as tickets went up for sale, they were





9pm, at the Pacifica Community Center, and YAB themed it as the Blizzard Bash. There were 220 tickets sold for this dance. The dance was themed a "white out" where students were encouraged to wear white. We had 12 recreation staff, 9 YAB volunteers, and 3 parent chaperones working this dance. Dances are open the ticket sales to any middle schooler in Pacifica. That ranges from every middle school (IBL, Cabrillo, Vallemar, Ocean Shore, Good Shephard, and Pac Bay), every home school student, and even students that are middle schoolers at schools outside of Pacifica, but they are

still a Pacifica resident. Each dance ticket sells for \$10. Both dances' staff hired DJ Art De Vera, who has been very well liked by the community. The next dance will be on February 2nd, 2024

Special Events

Halloween Spectacular

Halloween Spectacular was held on October 28th, at the Pacifica Community Center. Halloween Spectacular consisted of a haunted house, carnival games inside the auditorium, and carnival rides outside on the front lawn. The haunted house was decorated mainly by recreation Staff, but we had two outside groups come and decorate their own rooms. The Pacifica Police department had a spooky crime scene room, and the Pacifica Girl Scout troops decorated their room as a mystical werewolf territory. Recreation Staff, the Police Department, and the Girl Scouts, spent 5 hours the day before the event setting up the rooms accordingly for the event. Recreation staff ran the carnival, where there were 12 different games/



activities to choose from. The event cost \$10 for entry to the Haunted house and access to the carnival, or there was an option to skip the haunted house and just pay for carnival tickets, where \$1 would get you 4 carnival game tickets. This was a one-night event that ran from 5-10pm, and attendance was around 1,000 people come through the event the entire night.

Ohlone Portola Heritage Hike

On November 4th at 9am, the annual Ohlone Portola Heritage Hike/ discussion took place. Participants met at the community center at 9am, where there were poster boards with information about the Ohlone Heritage, and then two videos that were shown with more information on the land, heritage, and culture.

Members from the Historical society came and presented, along with a ranger from San Mateo County parks. Around 25 people showed up for the presentations, and 5 people went on the hike.

Electric Vehicle Expo

On November 4th at 10am, the second annual EV Expo happened in the Pacifica Community Center's parking lot. People from the public were welcomed to sign up and show off their Electric vehicle, and others were welcome to come stop by and learn more about electric vehicles. This was presented by Pacifica's Environmental family, partnered with the City of Pacifica, Peninsula Clean Energy, and Pacifica Climate Committee. There were many electric vehicles being shown off, a very interesting mix of new and older models.

Pacifica Polar Palooza

The Pacifica Polar Palooza was a three-day event that started the night of December 1st. On the first day of the Pacifica Polar Palooza, staff hosted the annual holiday building lighting ceremony that started at 6pm at the Pacifica Community Center. The holiday building lighting was a great kick-start to the event, Director Bob Palacio and former Mayor Bigstyck said a few words to the patrons and started the countdown to the building lighting. As soon as the building was lit, a choir from illuminate music broke into various holiday songs for a wonderful choir performance. The choir consisted of around 20 school age children. Shopping Trips

Monthly shopping trips to the local Safeway and Grocery Outlet have been a huge hit with the seniors and their shopping needs. Between October 1st and December 31st staff offered 6 shopping trips serving seniors, offering 19 roundtrips.

Shopping Assistance for Homebound Seniors (SASH)

SASH volunteers shop for homebound seniors in need of groceries and household supplies. There currently are 4 Sash clients and 1 SASH Volunteer. Our volunteer shop for our clients once a week for the past 3 months.

Medical Supply Loan Program

The Medical Supply Loan Program continues to be an extremely needed serve. Items loaned included crutches, canes, walkers, shower chairs, commodes, and wheelchairs. During this quarter we provided 26 pieces of equipment as well as giving out incontinent supplies. Staff continues excepting additional equipment to stock up our medical closet.

CaR Program (Connect a Ride) update:



CaR ridership continues to increase and expand, we have witnessed an increase in trips for medical appointments. There are currently 488 Pacifica residents 65+ years old registered in the program since the roll-out November 4, 2019.

Senior Nutrition Programs

Meals on Wheels (MOW)

- Pacifica Senior Services is currently servicing 100 homebound clients.
- Meals continue to be delivered fresh daily Monday-Friday and frozen meals for weekend and holidays delivered on Fridays or the day before the holiday. Out of 100 clients, 21 of them requested frozen meals for the weekend and holidays.
- Approximately, 6200 meals have been served in the October- December 2023.
- The average client donation for service is \$1.30 per meal.
- Staff continue to build out our substitute volunteer pool. Routes continue to be covered and reliant on committed volunteers, looking for a permit volunteer for Route 7 on Tuesday. There are 38 consistent volunteers who are assigned to a route and an additional several volunteers who are called upon to substitute.
- The program operates 8 meal delivery routes per day, our longest route currently is Route 2 with 18 clients in our Linda Mar neighborhood and shortest route currently is Route 4 in the Sharp Park neighborhood. Staff continues working on building out the routes by enrolling new clients and processing their intakes as soon as possible
- San Francisco State University (SFSU) School of Nursing students finished their semester work the first week in December and were instrumental to Meals on Wheels. The skilled nursing students are assisting with completing the required quarterly re-assessment which are done via home visits while others are completed via telehealth. These re-assessments are vital to our program as it ensures that seniors continue to qualify for Meals on Wheels. Students also assist with running a route in the morning and checking in with seniors to make sure that they are safe at home and have the necessary resources and information to thrive independently and with dignity. The feedback continues to be positive, and we look forward to our continued partnership with San Francisco State University! A new group of four students will be returning the in February 2024.

• In December, through the generous donations from the Pacifica Police Officers Association, Pacifica Police Supervisors Association, Pacifica Police Reserve Officers, and department staff, we were able to provide \$25 gift cards to the clients of Meals on Wheels. There were also additional donations from LaFayette Family Trust for \$300.00 and Pacifica Garden Club \$150.00 to help support the program.
