

RESOLUTION NO. 38-2024

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA
TO APPROVE AMENDMENT NUMBER 2 TO THE VENDOR SERVICES AGREEMENT WITH
UNIVERSAL BUILDING SERVICES (UBS) TO PROVIDE ADDITIONAL JANITORIAL
SERVICES FOR CITY RESTROOMS AT LINDA MAR STATE BEACH, PACIFICA PIER,
ROCKAWAY BEACH, FRONTIERLAND PARK AND OUTSIDE THE COMMUNITY CENTER**

WHEREAS, the public city restrooms at Linda Mar State Beach, Pacifica Pier, Rockaway Beach, Frontierland Park, and outside the Community Center need daily cleaning and twice a day cleaning during the high season (May-October) to remain clean and sanitary; and

WHEREAS, the Rangers currently clean these restrooms, although outside of their classification, taking away from other important Ranger tasks such as safety monitoring, wildlife protection, parking control, enforcement of rules, conflict resolution, addressing complaints and responding to emergencies; and

WHEREAS, on February 27, 2023, the Council approved a vendor services agreement with UBS for cleaning all city facilities, and on October 9, 2023, the Council approved a first amendment to the agreement for added services at the Community Center and Jean E. Brink Pool and UBS has been performing these services to expected standard; and

WHEREAS, on May 13, 2024, the City Council of the City of Pacifica considered the City Manager's recommendation to approve a second amendment to the agreement with UBS to provide additional restroom cleaning services;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pacifica to approve Amendment 2 to the vendor services agreement with UBS for additional janitorial services for city restrooms at Linda Mar State Beach, Pacifica Pier, Rockaway Beach, Frontierland Park and outside the Community Center in an amount of \$84,397.77, increasing the overall cost of the UBS Janitorial Services Agreement to \$343,657.77/year.


