OF MINUTES: The minutes for March 20, 2024 meeting was approved.

COMMISSION COMMENTS:

Commission Chair Crawford spoke about his recent review role of the Commission as indicated in the Pacifica Municipal Code. There was discussion that City Council had decided to review all of the City commissions and committees.

Commissioner Blackburn spoke about recent notices community members have been receiving about the loss of homeowners and fire insurance. He asked if this was a topic the City Council was aware of or would look into further. Commissioner Blackburn

would look into finding a copy of one of these letters of cancellation of insurance to share with the Chair and staff.

Commission Chair Crawford wanted to learn more about non-governmental organizations (NGOs) that could be resources during a disaster. He spoke about a group called Thrive, the Alliance for Nonprofits in San Mateo County.

EX-OFFICIO COMMENTS:

Ms. Fleming from the American Red Cross (ARC) shared that the county library system maintained a database of all non-profits and NGOs in San Mateo County. She also promoted the ARC program Sound the Alarm that encourages and even provides installation of smoke detectors in homes. ARC is seeking volunteers and donations to support this program.

COUNCIL LIASION COMMENTS:

Council Member Boles extended her appreciation to the police department who had been very busy handling a number of high-profile incidents and coping with challenging staffing levels.

Council member Boles spoke to the commission about the next phase of the local coastal land use plan (LCLUP) update. She encouraged commissioners to attend the next scheduled meeting which had not yet been announced. She also spoke about the upcoming annual report to City Council by Commissions and Committees, and reviewed expectations to keep presentations to a reasonable length.
