A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA
TERMINATING PROCLAMATION OF LOCAL EMERGENCY AT CARMEL AVENUE FROM
VALLEJO TERRACE TO CANYON DRIVE AND ACCEPTING INVOICES FROM PACIFIC
TRENCHLESS FOR EMERGENCY WORK RELATED TO LOCAL EMERGENCY AT
CARMEL AVENUE FROM VALLEJO TERRACE TO CANYON DRIVE
FOR A TOTAL OF \$298,607.00

WHEREAS, a local emergency existed in Pacifica in accordance with the proclamation thereof by the Director of Emergency Services on the 17th day of June, 2024, and its ratification by the City Council on the 24th day of June, 2024, as a result of conditions of extreme peril to the safety of persons and property discovered by Public Works Wastewater Division staff which involved approximately a nine hundred eighty-seven feet section of the 6-inch sewer main Carmel Avenue from Vallejo Terrace to Canyon Drive; and

WHEREAS, these conditions of the damaged 6-inch sewer main in danger of collapsing would create a hazardous condition including potential Sanitary Sewer Spills and threaten the safety of persons and property, including critical public infrastructure; and

WHEREAS, time was of essence to repair the damage 6-inch sewer main and as allowed by the Pacifica Municipal Code the City Manager was authorized to proceed at once with emergency repairs without plans, specification, or giving notice to let bids; and

WHEREAS, Pacific Trenchless has extensive sewer main repair experience and completed the repairs including the repair of 146 linear feet of open trench sewer replacement for 6-inch PVC pipe, as well as the repair of 841 linear feet of pipe bursting replacement of 6-inch VCP pipe, and the cost for this work is \$298,607.00. Pacific Trenchless started this work on Monday, June 24, 2024, and the work was completed on July 12, 2024; and

WHEREAS, the situation resulting from said conditions of extreme peril is now deemed to be within the control of the normal protective services, personnel, equipment, and facilities of and within Pacifica. The City Manager, as Director of Emergency Services, and staff now recommend the City Council approve the Resolution Terminating Proclamation of Local Emergency at Carmel Avenue from Vallejo Terrace to Canyon Drive and accept invoices from Pacific Trenchless for the emergency work related to the local emergency for a total cost of \$298.607.00:

NOW, THEREFORE, the City Council of Pacifica, State of California, does hereby proclaim the termination of said local emergency and accept invoices from Pacific Trenchless for the emergency work related to the local emergency on June 17, 2024, for a total cost of \$298,607.00.
