RESOLUTION NO. 80-2024

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA
APPROVING AN AGREEMENT WITH ENVIRONMENTAL SCIENCE ASSOCIATES (ESA)
FOR AN AMOUNT OF \$102,200 FOR MAPPING UPDATE SERVICES ASSOCIATED WITH
THE CITY'S DRAFT LOCAL COASTAL LAND USE PLAN (LCLUP); AUTHORIZING THE
CITY MANAGER TO EXECUTE THE AGREEMENT; AND FINDING THE ACTION EXEMPT
FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) PURSUANT TO
CEQA GUIDELINES SECTION 15061(B)(3)

WHEREAS, consistent with the City of Pacifica's Purchasing Policy (Administrative Policy No. 76), the City Council of the City of Pacifica has considered the City Manager's recommendation to enter into an agreement with Environmental Science Associates ("ESA") for mapping update services associated with the City's draft Local Coastal Land Use Plan (LCLUP); and

WHEREAS, updating maps in the City's draft LCLUP is critical for the implementation of the document;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pacifica hereby resolves as follows:

- 1) This action is not subject to review under the California Environmental Quality Act pursuant to Public Resources Code Section 21000, et seq. and CEQA Guidelines (14 Cal. Code Regs. §§ 15000 et. seq.) because it is exempt under CEQA Guidelines section 15061(b)(3) (common sense exemption) as it can be seen with certainty that there is no possibility that the services that will be provided by ESA to update the maps will have a significant effect on the environment.
- 2) The agreement is hereby approved and the City Manager is authorized to execute the agreement with ESA in the amount of \$102,000.
- 3) The FY 2024-25 Budget for this project includes \$50,000 and is hereby amended to appropriate the additional funds in the amount of remaining \$52,000 from the undesignated General Fund balance to fund the project.
