

**RESOLUTION NO. 82-2024**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA  
AUTHORIZING A MASTER AGREEMENT FOR CONSULTANT SERVICES AND  
TASK ORDER NO. 1 WITH FREYER AND LAURETA, INC. FOR ENGINEERING DESIGN  
SERVICES FOR THE VALLEMAR AND ROCKAWAY BEACH BOULEVARD AREAS  
SEWER REHABILITATION AND REPAIR PROJECT**

**WHEREAS**, during the FY 2023-24 Capital Improvements Program (CIP) budget approval process, the City Council approved funding for the Vallemar and Rockaway Beach Boulevard Areas Sewer Rehabilitation and Repair Project (Project); and

**WHEREAS**, the Project includes but is not limited to the engineering design and construction of the Project; and

**WHEREAS**, improvements to the collection system in the Vallemar and Rockaway Beach Boulevard areas were identified in the City's Collection System Master Plan Update 2021. The Project will include replacing existing sewer mains with new pipe and rehabilitating manholes to improve system reliability and reduce the risks of overflows as well as inflow and infiltration (I&I). In addition, three sanitary sewer pipeline segments crossing Calera Creek will be replaced and evaluated for new design alternatives, requiring additional engineering and potential environmental impact evaluations; and

**WHEREAS**, on July 3, 2024, the City advertised a Request for Proposal (RFP) to solicit proposals from engineering design teams (Consultants) to design and develop construction bid documents for the Project. Then on July 15, 2024, five consultants bid the Project; and

**WHEREAS**, as required by state Public Contracts Code, the RFP utilized a qualifications-based selection (QBS) approach to ensure the City selected the most qualified Consultant for this critical Project; and

**WHEREAS**, City staff ranked Freyer and Laureta, Inc. first and determined that they are the most qualified to perform the engineering design of the Project; and

**WHEREAS**, the City Council has considered the City Manager's recommendation to authorize a Master Agreement for Consultant Services and Task Order No. 1 with Freyer and Laureta, Inc.;

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Pacifica authorizes the City Manager to execute a Master Agreement for Consultant Services and Task Order No. 1 with Freyer and Laureta, Inc. for engineering design services in the amount of \$940,300 for the Vallemar and Rockaway Beach Boulevard Areas Sewer Rehabilitation and Repair Project and approves budget authority in the amount of \$1,081,345 which includes 15% contingency in the amount of \$141,045; and Authorizes the City Manager to execute all documents related to the Project.
