

RESOLUTION NO. 84-2024

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA SUPPORTING THE OCEANA BICYCLE AND PEDESTRIAN PROJECT AND SUBMITTING AN APPLICATION TO THE SAN MATEO COUNTY TRANSPORTATION AUTHORITY FOR CYCLE 7 PEDESTRIAN AND BICYCLE PROGRAM FUNDING

WHEREAS, the City of Pacifica (Sponsor) has identified a lack of bicycle infrastructure connecting the Manor and Sharp Park neighborhoods; and

WHEREAS, the Sponsor has developed the Oceana Boulevard Bicycle and Pedestrian Improvement Project (Project) to install Class II Bicycle markings as identified within the City's Bicycle and Pedestrian Master Plan; and

WHEREAS, it will cost \$2,000,000 to implement the Project to install bicycle and pedestrian improvements starting from Milagra Drive to Clarendon Road. The project also looks to improve some of the pedestrian intersections with high visibility crosswalks and signs; and

WHEREAS, the Sponsor seeks \$2,000,000 for the Project; and

WHEREAS, the San Mateo County Transportation Authority (TA) issued a Call for Projects for the Cycle 7 Measures A and W Pedestrian and Bicycle Program on June 10, 2024; and

WHEREAS, the TA requires the Sponsor's governing board to adopt a resolution:

1. Supporting the Project and application for \$2,000,000 in TA Measures A and W Pedestrian and Bicycle Program funds for the Project; and
2. Committing the Sponsor to the completion of the Project, including the commitment of matching funds in the amount of \$200,000 needed for implementation; and
3. Certifying that any funds awarded by the TA will be used to supplement existing funds for program activities, and will not replace existing funds or resources; and
4. If funds are awarded, authorizing the Sponsor's City Manager, or designee, to sign a funding agreement or memorandum of understanding (MOU) with the TA [and/or other parties, if applicable] for TA Measures A and W Pedestrian and Bicycle Program funding for the Project and to take any other actions necessary to give effect to this resolution and execute applicable amendments.

NOW, THEREFORE, BE IT RESOLVED that the governing board of the City of Pacifica:

1. Directs staff to submit an application to the San Mateo County Transportation Authority for Measures A and W Pedestrian and Bicycle Program funds for \$2,000,000 for Oceana Boulevard Bicycle and Pedestrian Improvements Project; and
2. Authorizes the City Manager or designee, to execute a funding agreement or MOU and any amendments with the San Mateo County Transportation Authority [and/or other parties, if applicable] to encumber TA Measures A and W Pedestrian and Bicycle Program funds; and

3. Commits to completing the Project, including contributing \$200,000 of matching funds needed for Project implementation, if the requested TA funds are awarded; and
4. Certifies that any funds awarded by the TA will be used to supplement existing funds for program activities, and will not replace existing funds or resources; and
5. Authorizes the City Manager, or designee, to take any other actions necessary to give effect to this resolution and execute applicable amendments.
