2. SP-153-15 File No. 2018-056 – Request for one year renewal of Specific Plan

SP-153-15 for the construction of a single-family residence at 323 Beaumont Boulevard (APN 009-037-450). Recommended CEQA

Action: No further CEQA required.

Sr. Planner Murdock presented the staff report.

Brian Brinkman, applicant, stated that original proposal had some terrace retaining walls in the backyard requiring extensive grading and structural work. When the construction costs exceeded their planned budget, they designed it to reduce the number of retaining walls and made it a more conventional structural design and they are now financially prepared to move forward. They are looking forward to the renewal and get started with construction next year.

Commissioner Rubinstein asked how long it has been in play.

Mr. Brinkman stated it was November 2016 when it was first approved.

There were no public comments.

Commissioner Kraske asked if there were any limitations on the number of times the applicant can apply for an extension.

Sr. Planner Murdock stated that there was not. It was their intention to limit the number and encourage applicants to complete their projects. In this case, given the timely filing of the renewal request, there was no limitation in the Municipal Code.

Commissioner Gordon moved that the Planning Commission finds that the renewal of Specific Plan SP-153-15 does not necessitate further environmental review of the Project under CEQA because the City has previously determined that the Project is exempt under the Class 3 categorical exemption provided in the CEQA Guidelines, and because the Project has not changed since that determination; and approves a renewal of Specific Plan SP-153-15 until November 15, 2019; Commissioner Rubinstein seconded the motion.

3. PSD-790-14 PV-513-14 PE-160-15 **File No. 2018-054** – Request for one year renewal of Site Development Permit PSD-790-14, Variance PB-513-14, and Parking Exception PE-160-15 for the construction of a four-unit apartment building at 4009 Palmetto Avenue (APN 009-402-270). Recommended CEOA Action: No further CEOA required.

Sr. Planner Murdock presented the staff report.

Michael O'Connell, applicant, stated that he wanted to point out that they have been working on their permits since the last extension, explaining that they applied for the Coastal Development Permit. While they haven't received it yet, the Coastal Commission has issued a notice of intent to issue the permit and they go through a rigorous plan check for the actual permit. He stated that they have approved the soft copies and they provided the hard copies the previous week. He stated that the only outstanding plan check for the city-issued building permit is to provide a copy of the CDP. They thought it is coming together but they have been working on getting the permit.

There were no public comments.

Commissioner Gordon moved that the Planning Commission find that the renewal of Site Development Permit PSD-790-14, Variance PV-513-14 and Parking Exception PE-160-15 does not necessitate further environmental review of the project under CEQA because the City has previously determined that the project is exempt under the Class 2, 3, and 4 categorical exemptions provided in the CEQA Guidelines and because the project has not changed since that determination; approve a renewal of site Development Permit PSD-790-14, Variance PV-513-14 and Parking Exception PE-160-15 until the earlier of (1) December 12, 3019 or (2) expiration of Coastal Commission0issued CDP No. A-2-PAC-15-0046; Commissioner Rubinstein seconded the motion.
