RESOLUTION NO. 25-2021

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2021-2022 FUNDED BY SB 1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our City of Pacifica are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City of Pacifica must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City of Pacifica, will receive an estimated \$755,871 in RMRA funding in Fiscal Year 2021-22 from SB 1; and

WHEREAS, this is the fifth year in which the City of Pacifica is receiving SB 1 funding and will enable the City of Pacifica to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City of Pacifica has undergone a robust public process to ensure public input into our community's transportation priorities/the project list; and

WHEREAS, the City of Pacifica used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities' priorities for transportation investment; and

WHEREAS, the funding from SB 1 will help the City of Pacifica maintain and rehabilitate several streets/roads and active transportation infrastructure throughout the City of Pacifica this year and many other similar projects into the future; and

WHEREAS, the 2018 California Statewide Local Streets and Roads Needs Assessment found that the City of Pacifica's streets and roads are in an "poor" condition and this revenue will help us increase the overall quality of our road system and over the next decade will bring our streets and roads into a "at risk" condition; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.

NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND by the City Council of the City of Pacifica, State of California, as follows:

- 2. The following list of newly proposed projects will be funded in-part or solely with Fiscal Year 2021-22 Road Maintenance and Rehabilitation Account revenues:

Project Title: FY 2020-21 & FY 2021-22 Pavement Resurfacing

Project

Project Description: The project will resurface approximately 11 miles (64

street sections) of City pavement and includes cape seal, double slurry seal, slurry seal, microsurfacing, base repair, pavement striping and markings and

other miscellaneous related work.

Project Location: Various Streets and Roads, See attached list.

Estimated Project Schedule: July 2021 – October 2021

Estimated Project Useful Life: 5 to 10 Years

The following previously proposed and adopted projects may also utilize Fiscal Year 2021-22 Road Maintenance and Rehabilitation Account revenues in their delivery. With the relisting of these projects in the adopted fiscal year resolution, the City of Pacifica is reaffirming to the public and the State our intent to fund these projects with Road Maintenance and Rehabilitation Account revenues:

Project: FY 2020-2021 Pavement Rehabilitation Project

Description: This project will rehabilitate the pavement along

Fassler Avenue from Driftwood Circle to Crespi Drive and Crespi Drive from Fassler Avenue to Lerida Way and include cape seal, double slurry seal, slurry seal, microsurfacing, base repair, pavement striping and markings and other miscellaneous related work.

Location: Fassler Avenue and Crespi Drive

Anticipated Year of Construction: July 2021 – October 2021

Estimated Useful Life:

5 to 10 Years
